HPSCI Deputy Staff Director Darren Dick has engaged with both HOCR and with the Speaker's Office on the letter; HPSCI's plan is to make clear to HOCR that any issue re CIA personnel is properly in HPSCI's lane. HPSCI counsel Wheelbarger is in contact with HOCR and has promised to work with us to craft a response to the Issa letter that will keep the matter with our oversight. She was out last week, but [redacted] was in contact with her today and is following up.

We do not plan to communicate directly with HOCR; any response with go through HPSCI.
