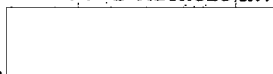

[REDACTED] COMMENT: SEE SANTIAGO EMBASSY TELEGRAMS 5115 OF 23 JULY, 5185 OF 25 JULY AND 5190 OF 25 JULY FOR DETAILS OF THE DEATH LISTS PUBLISHED IN ARGENTINA AND BRAZIL, INCLUDING THE FACT THAT OVER 100 OF THE PERSONS CITED WERE INCLUDED ON A LIST OF 166 "DISAPPEARED" PERSONS, WHICH THE CHILEAN INTER-DENOMINATIONAL PEACE COMMITTEE HAD PRESENTED TO THE SUPREME COURT IN MAY 1975 IN AN APPEAL FOR A GENERAL INVESTIGATION SINCE MOST HAD BEEN THE SUBJECTS OF HABEAS CORPUS REQUESTS.)

4. WITH REGARD TO THE ULTIMATE SOURCE OF THE PRESS ARTICLES, [Redacted] IN CHILE SPECULATE THAT THE INFORMATION WAS GIVEN TO THE PRESS BY EITHER THE MIR OR THE UNITED NATIONAL HUMAN RIGHTS COMMISSION (UNHRC) WHICH

3.3(b)(1) WAS RECENTLY REFUSED ENTRY INTO CHILE, OR EVEN BY MEMBERS OF THE PEACE COMMITTEE ITSELF. IN AN EFFORT TO BRING PRESSURE TO BEAR ON THE JUNTA GOVERNMENT TO DISCLOSE THE DESTINY OF THE MISSING PERSONS. AS BASIS FOR THEIR SPECULATION, [REDACTED]

[REDACTED] POINTED TO THE FACT THAT PRIOR TO CANCELLATION OF THE UNHRC VISIT, FAMILY MEMBERS OF ALL THE MISSING PERSONS HAD INDICATED TO THE PEACE COMMITTEE THEIR DESIRE TO TESTIFY BEFORE THE UNHRC.

3.3(b)(1) 5. [REDACTED] DISCOUNT THE POSSIBILITY THAT THE GOVERNMENT PLANTED THE STORY, ON THE BASIS THAT IT WOULD BE FOOLISH TO PLANT INFORMATION WHICH WAS INHERENTLY DETRIMENTAL TO THE GOVERNMENT. [REDACTED] COMMENT: SANTIAGO EMBASSY TELEGRAM 5190 REPORTED THAT MEMBERS OF THE PEACE COMMITTEE SPECULATED THAT WITH THE IMPENDING UNHRC VISIT, THE SECURITY FORCES MAY HAVE FELT PRESSURED TO ACCOUNT SOMEHOW FOR THE 166 MISSING PERSONS WHO WERE BELIEVED TO BE IN GOVERNMENT HANDS. WITH REGARD TO THIS LATTER THEORY, IT IS WORTH NOTING THAT THE UNHRC VISIT WAS CANCELLED ON 4 JULY AND THE FIRST PRESS ARTICLE DID NOT APPEAR UNTIL 22 JULY.)
