RUDKO, MYKHAYLO [] ON 10 AUGUST 1956, THE EAST BERLIN COMMITTEE'S UKRAINIAN BRANCH IN GERMANY, 'DNIPRO', MAILED FROM INGOLSTADT AND MUNICH A NEW PAMPHLET WHICH IS CONCERNED WITH SIMON PETLYURA, /REV./ IVAN HRYNIOCH, ZENON MATLA, MYKHAYLO RUDKO, IVAN KASHUBA AND VOLODYMYR KOZAK. THE PAMPHLETS SAY THAT HRYNIOCH AND MATLA HAVE BECOME DIS-ENCHANTED WITH NATIONALISM AND THE OTHERS HAVE BEEN 'HANDLING YOUR BLOOD', I.E., RECRUITMENT OF EMIGRES FOR DISPATCH INTO THE UKRAINE AND OTHER ESPIONAGE OPERATIONS, ETC. I PERSONALLY ASK THE QUESTION: WHY HAS THE COMMITTEE SINGLED OUT RUDKO, KASHUBA AND KOZAK. MY REPLY IS FOUND ONLY IN THE FOLLOWING: AMONG OTHERS, RUDKO IS OFTEN MENTIONED IN ZCH/OUN/BANDERA CIRCLES AS HAVING BEEN TRAINED IN ESPIONAGE BY THE AMERICANS AND FURTHER BECAUSE HE IS EMPLOYED BY UJARC IN ASSISTING NEW REFUGEES. THE ENTIRE EMIGRATION KNOWS THAT KASHUBA IS CHIEF OF BANDERA'S SB /SECURITY SERVICE/.
