CONSOLIDATED INTERROGATION REPORT (CIR) NO 4

SUBJECT: The German Sabotage Service

DATE: 23 July 1945

This report consolidates information on the German sabotage services obtained from SKORZENY and his adjutant, RADL. It is to be read in conjunction with CIR 4/6 of 31 May 45 and HQ 12 AGP Interrogation Center IIR, dated 4 Jun 45.

1. SCHEMES OF INFORMATION

(O/Stubat Oppo/ SKORZENY, Head of Gruppe VI-S, RSHA, the Jagd Verbaende and Mil D, arrived at USSET Interrogation Center on 19 May 45.

(Stubat) Karl RADL, Head of Referat VI-S/2, ^{677C}SKORZENY's Adjutant, arrived at USSET Interrogation Center on 19 May 45.

A good deal of discrepancy exists between SKORZENY's and RADL's estimates of the size and effectiveness of the sabotage organizations. RADL attributes this to SKORZENY's frequent absence from his Headquarters on active operations. By losing touch with administrative details, he did not realize the wide gulf which existed between his plans and their execution. In addition, his gullibility and enthusiasm led him to believe every dressed-up report submitted by his ambitious inferiors.

SKORZENY's leadership was inadequate, according to RADL. After the successful MUSSOLINI rescue, HITLER and HIMMLER used him for all sorts of special missions at the expense of the agencies he was supposed to be organizing. This scattering of his interests became absolute early in 1944 when he became the chief exponent of the Sonder Kampf (miracle weapons) idea. He realized that even if there were still any hope for a German victory, it would prove a Pyrrhic one unless the losses at the front could be cut down. He threw himself into the employment of the new weapons, hoping that they would bring victory, hoping that they would prove the answer to the problem.

RADL is more accurate than SKORZENY on detailed information. In his opinion, SKORZENY's sabotage services were bound to fail.

2. REPORT

a. German Sabotage Agencies

The three main sabotage agencies in Germany, all headed by SKORZENY, were:

- (1) Gruppe VI-S of RSHA
- (2) The SS Jagd Verbaende
- (3) Mil Amt D of RSHA

The lines of distinction between the three organizations were not always clear, and the tendency was toward amalgamation.

In order to place all German sabotage activities under a unified command and to increase their effectiveness, SKORZENY strove to incorporate Mil Amt D and VI-S completely into the Jagd Verbaende organization. The plan was to absorb VI-S and Mil Amt D into the central Jagd Verbaende Fuehrungs Stab, and all Mil Amt D Leit Stellen and VI-S Aussen Stellen into the Fuehrungs Staebte of the four Territorialen Jagd Verbaende.

The amalgamation was never completed because no officers of sufficient caliber could be found to command the proposed composite units, and because SCHELLENBERG refused to relinquish control of VI-S and Mil Amt D to the Jagd Verbaende. The latter as essentially military units were subordinate to the SS Fuehrungs Haupt Amt rather than RSEA. In spite of these limitations, SKORZENY tried to put his plans into operation, effecting a considerable merging of functions and personnel.

In the fifth year of the war his efforts came too late. Personnel was selected without regard for suitability. None of the men in leading positions had ever been abroad or spoke any foreign languages. Most of them were too young for the responsibilities they were supposed to assume.

(1) Gruppe VI-S.

Gruppe VI-S was organized in the Berkaer Strasse, BERLIN, in November 1943, moving to Schloss FRIEDENHALL in May 1944.

It consisted of four Referate with the following functions:

VI-S/1. Administration, finance, procurement of foreign currency; contracts, leases, upkeep of real estate; liaison with VI-A and Amt II.

Referent: H/Stuf SCHMIEL; H/Stuf PODLECH in charge of finance section; U/Stuf WINDHOEVEL, contracts and personnel matters.

VI-S/2. Adjutant. Incoming correspondence. Contacts with outside agencies. RADL was adjutant.

VI-S/3. Administration of the schools, including procurement of funds and recruiting of personnel; supervision of instruction.

Referent: H/Stuf BRAMFELD, assisted by U/Stuf PALOW.

VI-S/4. Operation of agents, planning, supervision of training.

Referent: H/Stuf BESEKOW, assisted by O/Stuf MEIER.

SKORZENY considers the division into Referate to be largely theoretical. It was maintained as a concession to SCHELLENBERG, who wanted to adhere to the existing Amt VI organization. In practice it was simply a HQ staff working in close cooperation.

When RSHA was ordered to evacuate BERLIN in January 1945, VI-S went to HOF with the Fuehrungs Stab of the Jagd Verbaendo. The situation deteriorated rapidly, and it became impossible to communicate with RSHA, Amt VI, or Mil F.

Gruppo VI-S was dissolved when SKORZENY dismissed all non-essential personnel and moved his HQ on a special train to Austria.

(2) Jaeger Btl 502 (not).

SKORZENY asserts that from the very beginning his aim was to rid the German sabotage activities of RSHA political control and to turn them into purely military operations. His personal dislike for SCHELLENBERG was also an important factor in this policy. It should be borne in mind, however, that such a policy coincides with his present effort to paint himself as a military rather than a political figure.

With this aim in mind he established contact with the SS Fuehrungs Haupt Amt immediately after taking charge of VI-S, and obtained the authorization to activate Jaeger Btl 5-2 (not) in June 1943.

The cadre was provided by SS Sonder Lehrgang ORANIENBURG, which had been founded the year before by VI-F. It was commanded by H/Stuf VESSEM and consisted of appr 70 NCOs and 30 other EM, all fanatical SS men who had volunteered for dangerous missions. It had engaged in one operation in 1943, known as Einsatz Franz, when O/Stuf BLUME went to Iran in an attempt to contact insurgent groups. The mission was unsuccessful and ended with BLUME's arrest.

In May 1943 the Lehrgang was quartered in the ORANIENBURG SS barracks. During the summer it moved to FRIEDENTHAL and was renamed Sonder Lehrgang zbV FRIEDENTHAL. The first operation executed under SKORZENY's command was the liberation of MUSSOLINI. In the meantime the authorization to activate Jaeger Btl 502 had been granted and the Sonder Lehrgang was absorbed into the new unit.

As all SS units in the 500 series were probationary troops recruited from convict SS personnel, and the activation order for Jaeger Btl 502 specified that the SS fuehrungs Haupt Amt was not to supply any men or materiel, considerable difficulties were encountered. Personnel was drawn from the probationary camp in CHLUM, Czechoslovakia. Ninety percent proved unsatisfactory and were sent back. SKORZENY then proceeded to recruit volunteers from the army (150), the GAF (50), and the SS (100). This enabled him to form HQ Co and 1 and 2 Cos. Appr 30 men were sent to the HAVEL Institut for W/T instruction. The others underwent strenuous inf training and engr and motor courses were added later.

In the fall of 1943 1 Co, led by H/Stuf VESSEM, was sent against the partisans in Croatia. 3 Co was formed in February 1944 with H/Stuf HOYER as CO. Personnel was mainly Flemish and Dutch. At the same time, 1 and 2 Cos went to TUP KURMARK for four weeks' training and were in combat on the Eastern front for four to six weeks. Unsuitable officers and men were eliminated to the extent of 10 - 15%.

The authorized T/O called for 1,200 men organized in five Cos, but this figure was never reached. The unit's final strength was 700 men, comprising a HQ Co and three line Cos. SKORZENY was Bn CO. VESSEM remained CO of 1 Co and deputy Bn CO until his return from Croatia. He was replaced by H/Stuf WENZEL, who held the position until April 1944, when H/Stuf von FOELKERSAM, the I-a, became SKORZENY's second in command.

Jaeger Btl 502 was dissolved and its personnel absorbed into the Jagd Verbaende, mainly Jagd Verband Mitte, in September 1944 (cf Annex I).

(3) The SS Jagd Verbaende.

The SS Jagd Verbaende consisted of four Territorialen Jagd Verbaende, known as Jagd Verband Ost, Sued Ost, Sued West, and Nord West; and two purely German bns, Jagd Verband Mitte and Fallschirm Jaeger Btl 600. The latter were organized in order to have sufficient German personnel available for special tasks such as parachute or glider operations like the MUSSOLINI rescue. The detailed organization of the various units is discussed in Annex I.

In August 1944 the Wehrmacht Fuehrungs Stab ordered the re-organization of Div BRANDENBURG into a Pz Div. Two months previously the normal combat elements and the special (zbV) elements of Div BRANDENBURG had been separated when the personnel trained for special missions and acquainted with foreign languages was formed into so-called Streif Korps, which were attached to army corps for the execution of special missions.

These Streif Korps formed the nuclei of the Territorialen Jagd Verbaende when SKORZENY received the authorization to recruit 800 BRANDENBURG volunteers late in September. 1,200 were in fact recruited, but only 900 remained after the unfit had been eliminated. SKORZENY also recruited 2,500 men from the Ersatz Heer during November and December, and was authorized by O/Gruf BERGER of the SS Haupt Amt to draw volunteers from the foreign SS units.

The Territorialen Jagd Verbaende were separate bns drawn from political and nationalist groups in the countries where they were to operate. Plans for their formation were made by SKORZENY and von FOELKERSAM in May or June 1944, and the bns were activated in September by order of O/Gruf JUETTNER, head of the SS Fuehrungs Haupt Amt. A Jagd Verband was to be available to the Armed Forces in each theater to carry out special tasks in the tradition of the defunct Div BRANDENBURG. The final aim was to have all units engaged in sabotage behind the enemy lines under a unified command in theater territory, i.e. the Fuehrungs Stab of the Territorialen Jagd Verband.

In spite of the pressure of time, the organization was to proceed slowly, allowing the units to grow gradually so that mistakes could be recognized and avoided. The mistake made with Div BRANDENBURG, when irreplaceable personnel with knowledge of foreign languages and countries was committed as ordinary combat troops, was not forgotten. Accordingly the bns were to remain separate and independent units and not to be organized into regiments or a single division. Both SKORZENY and RADL claim that this independence went so far as to preclude their personal knowledge of organizational details.

(4) Schools.

Originally the "S" in VI-S stood for "Schulen" (schools). SKORZENY states that at his initiative all RSHA sabotage activities were taken out of VI-F and VI-S was established as the Amts Gruppe in charge of all operations. BESEKOW's original task was to study foreign sabotage methods and work out training plans on the basis of this research. As the organization of the SKORZENY apparatus progressed, all schools and training programs came under VI-S/3 (BRAMFELD) and, later under the I-a Jagd Verbaende Fuehrungs Stab (HUNKE).

There were two types of schools:

The A(genten) - Schulen
The Kampf Schulen of the Jagd Verbaende.

a. A-Schulen

The A-Schulen were training schools for sabotage agents. Subjects covered were sabotage methods, demolitions, W/T operation, and firing of weapons.

The training schedules were determined by VI-S/3 in BERLIN. Two to four weeks before the beginning of each course the schools received instructions as to the number and nationality of the prospective students, and the purpose and length of the course. The training was designed to be as varied and interesting as possible. Students were given the opportunity to swim, attend movies, engage in sports, and read books in their own language. Their teachers were constantly with them.

Upon completion of each course individual progress reports were issued, determining the student's further employment.

A-Schule West. This school was in the initial phase of its organization when SKORZENY took it over in June 1943. It had been established by VI-F at a country estate between The HAGUE and SCHEVENINGEN.

The school was ready to open in November 1943. As Jaeger Btl 502 and VI-S/4 were not ready to start operations at that time, VI-B, -C, -D, and -E were asked to send agents for sabotage and W/T training. Instructors were supplied by VI-F.

Between November 1943 and June 1944 the following groups of agents were trained in classes lasting 4 - 6 weeks at the school.

Apr 25 Arabs from the Italian-Arabian Legion.
Few were ever used as VI-S and Jaeger Btl
502 did not take any.

60 - 75 Italians (three classes).
Unsatisfactory with the exception of one
class.

20 Sorbian militia.
Good material, eager to learn and act.

Apr 15 Frenchmen.
Apr 10 Belgians.

In the spring of 1944 there were several courses of the same length for group leaders of the projected invasion nets, attended by:

10 - 15 German-Romanians,
10 - 12 Frenchmen, and
6 - 8 Belgians.

A W/T course, lasting several months, was opened in December 1943. The technical direction was in the hands of a Dutch radio engineer. The course was conducted by a German technician from the HAVEL Institut.

The students included:

2 Arabs,
2 Italians, and
4 Frenchmen and Belgians.

The HAGUE school was dissolved in June 1944. Stubaf KNOLLE was relieved of his command and sent to HEINRICHSBURG. H/Stubf WINTER took the remainder of the personnel to NEUSTRELITZ.

NEUSTRELITZ. The school was opened at the NEUSTRELITZ barracks in July or August 1944. After the Jagd Verbaende were formed it became 4 Co, Jagd Verband Nord West.

Classes began in September/October 1944. The school was primarily the Kampf Schule for Jagd Verband Nord West (see Kampf Schulen). SKORZENY states that few agents were trained. Appr 10 - 15 Frenchmen and 6 - 10 Belgians attended two-week courses with five to six men per course.

From November 1944 to March 1945 the school was devoted almost exclusively to Werwolf training. (See CIR 4/6 Par 6.)

HEINRICHSEURG. Early in 1944 the necessity for an A-Schule for the South East became apparent. O/Stubaf APPEL was given the task. He decided to establish it in guerilla territory and selected a tourist hotel on the HEINRICHSEURG in the Fruska Gora, NW of RUMA, Yugoslavia. Inevitable attacks by guerilla bands were to furnish the students with combat experience. (SKORZENY says that the school and the local guerilla bands shared the same doctor, who divided his time between them.)

As his cadre APPEL selected a Co of Serbian Moslems, reinforced by a German platoon from Jaeger Btl 502.

From July to September 1944, the following personnel was trained:

40 Italians (two classes),
25 Serbs,
120 Russians, and
20 Hungarians.

APPEL was replaced by Stubaf KNOLLE in July or August 1944. The school had to be abandoned when the Russians approached in September 1944. At that time the Russian class was in progress. The students and the Moslem Co were sent to the front. KNOLLE was recalled to BERLIN. Stubaf ZIMMER took the remainder of the personnel to MUEZZ ZUSCHLAG, Lower Austria, where the school was operated from November 1944 to February 1945 as part of Jagd Verband Sued Ost. Some Roumanians and Hungarians were trained.

b. Kampf Schulen

The Kampf Schulen were conducted on a much more military basis than the A-Schulen. In addition to the necessary fundamentals of sabotage, the students were taught to shift for themselves when left behind the enemy lines singly or in small groups. This implied intensive terrain intelligence training and toughening courses. W/T instruction was given sporadically.

The Kampf Schulen were founded by Div BRANDENBURG, and incorporated into the Jagd Verbaende along with the Streif Korps, to which they were attached. Their purpose was both the training of military personnel, and agents for sabotage operations. Theoretically each Jagd Verband was to have one or more schools. However, Jagd Verbaende Ost and Nord West did not receive any BRANDENBURG contingents. Therefore Jagd Verband Ost did not have any school, while A-Schule NEUSTRELITZ was largely converted for the purpose by Jagd Verband Nord West.

The Kampf Schule of Jagd Verband Sued West was located in FREIBURG/Breisgau. It was moved with the Fuchrungs Stab to Kloster TIEFENTHAL near WIESBADEN in the autumn of 1944. The opening of an advanced school for selected personnel was planned. It was to be established near HEIDELBERG. Due to the progress of the war, the plan did not materialize.

In Jagd Verband Sued Ost training was decentralized. Jagd Einsatz Runenien had a school at KORNEUBURG. Jagd Einsatz Ungarn conducted courses in the former AA barracks at WIENER NEUSTADT.

c. Swimmers' School, Diana Bad, VIENNA

The school of Jagd Einsatz Donau was located in the Diana Bad, VIENNA. All swimmers were gathered there in September/October 1944 after being withdrawn from the KdK training camps VALDAGNO, BAD TOELZ, and VENICE. A requisitioned rowing club on the Danube near KLOSTER-NEUBURG was to be used for training during the summer.

Appr 60 men were trained under the guidance of U/Stuf SCHREIBER.

(5) Mil Ant D.

The General confusion marking the administration of the German sabotage services reigned supreme in Mil D. The long struggle for power between the SS and the army is epitomized in its history, and the welter of political rivalries and personal bickerings make it difficult to gain a clear picture of its organization and functions.

Its history may best be understood if one examines the history of Mil Ant as a whole.

Officially, RSHA wanted to gain control over the Abwehr, under the banner of unification of the GIS. Unofficially, Abwehr leadership was considered politically unreliable, and Amt VI also wanted to use the Abwehr machinery abroad for its own political intelligence service. The inefficiency of Admiral CANARIS and his staff helped RSHA in this struggle.

The big opening came in the spring of 1944 when all Abwehr personnel in Turkey deserted to the British. In May HITLER ordered the unification of the GIS under RSHA control. The new over-all term was Geheimor Melde Dienst (GMD) (Secret Report Service). Abwehr was attached intact to RSHA as Mil Ant. Admiral CASLARIS was retired; Obst i G HANSEN, the former head of Abwehr II, was appointed head of Mil Ant, and Obst i G FREYTAG-LORINGHOFEN became the head of Gruppe II.


The Wehrmachts Fuehrungs Stab was forced to comply with HITLER's order. Nevertheless, it countered with the following moves:

- a. Div BRANDENEURG was removed from the jurisdiction of Abwehr II, and subordinated directly to the Wehrmacht Fuehrungs Stab a few days before the order was published.
- b. A new department was formed in the OKH, called Abteilung fuer Heerwesen (Dept for Army). All FAK Leit Stellen were directed to report to and accept their orders from the newly created department, which was responsible to the Wehrmacht Fuehrungs Stab. For all practical purposes Mil Ant was bypassed except for receiving a copy of all reports. The official reason given was that the interests of the frontline troops would be endangered by an over-complicated chain of command.

When FREYTAG-LORINGHOFEN was removed from his position as head of Mil Ant II because of political conservatism, the Wehrmacht Fuehrungs Stab put him in charge of the Abteilung fuer Heerwesen. Thus his influence was actually increased.

Maj i G NAUMANN replaced him as head of Mil Ant II.

This was the situation until 20 Jul 44:




————— actual chain of command


After the abortive assassination attempt HANSEN was executed. SCHELLENBERG took over Mil Amt, which was reorganized after the Ant VI pattern. The Ant VI Gruppen heads took charge of the newly created departments. SKORZENY became head of Mil D and Mil D/T. Maj i G NAUMANN remained as deputy.

FREYTAG-LORINGHOFFEN committed suicide and the Abteilung fuer Heerwesen was dissolved. A new agency was created by the Wehrmacht Fuehrungs Stab to take its place, the Wehrmacht Fuehrungs Stab I-c under Obst i G von SUESSKIND-SCHWEND. The name was different; the function was the same. Once again Mil Amt was bypassed:



SCHELLENBERG attempted to counteract these maneuvers of the Wehrmacht Fuehrungs Stab and gain direct control over the FAK Leit Stellen. His efforts were apparently successful in the fall of 1944, when the Wehrmacht Fuehrungs Stab agreed to dissolve its I-c department. Mil Amt was to control the Leit Stellen. One condition was made, however. In order to safeguard frontline interest, a new section was to be created within the Mil Amt to coordinate all frontline Abwehr activities. It was to be known as Mil F (Chef fuer Front Aufklaerung) (Chief of Front Reconnaissance).

Obst i G BUNZROCK, formerly I-c with Army Group WIESSNER, was appointed head of Mil F. From the beginning he was a puppet of the Wehrmacht Fuehrungs Stab. He immediately demanded exclusive control of all Leit Stellen. The net result was that the Mil Amt section controlling the FAK was an agency of the Wehrmacht Fuehrungs Stab. All other sections were bypassed as before:

All FAK personnel matters were handled by the Heeres Personal Amt. RSHA could not possibly infiltrate.

The organization and functions of Mil D must be regarded in the light of these developments. A wide discrepancy existed between its official and actual status. Officially it was the central controlling agency for all Leit Stellen II (-West, Sued Ost, and Ost-); their FAK (200 - 299), and FAT (200 - 299). Actually the Wehrmacht Fuehrungs Stab never relinquished its control.


(Some confusion may arise from the fact that the official German abbreviation "FAK" was used in a dual sense:

- a. for Front Aufklaerung, i.e. a generic term including Leit Stellen, Front Aufklaerungs Kommandos, and Front Aufklaerungs Trupps,
- b. for Front Aufklaerungs Kommandos only.)

The following is the official version:

Mil D had three Referate, one per Leit Stelle. Referat West was under Hptm SCHOEMAICH, Sued Ost under O/Lt FERIT, and Ost under O/Lt GAMBEKE. They were in control of all FAK sabotage operations in their respective theaters.

The diagram below shows the official chain of command:



There were two types of operations:

- a. Those directly behind the ~~army~~ lines (frontnahe Ein-saetze),
- b. Those further to the rear (frontferne Ein-saetze).

Category a. was supervised by frontline commanders.

Only the general directives were laid down by Mil D. A FAK or FAT could suggest an operation to army or corps. The I-c of army or corps in turn could request a FAK or FAT to undertake one. A complete report on the results was sent to corps, army, and the respective Leit Stelle II, which in turn referred to it in a monthly report to Mil D. Only operations of particular interest were reported separately.

C O N F I D E N T I A L

The necessity for operations of category b. was determined by army groups, the Wehrmacht Fuehrungs Stab, or Mil D, on the basis of information gathered by Amt VI and Mil Amt intelligence sources.

Plans for large scale operations involving great difficulties, large sums of money, or possible political implications (such as operations in neutral countries), were worked out by the Referat chiefs, and submitted to SKORZENY and SCHELLENBERG for approval. SKORZENY was permitted to authorize expenses up to RM 3,000 in German and RM 1,000 in foreign currency.

The Leit Stellen received their orders by teletype or radio.

Locations.

Mil Amt D was located at Schloss BARUTH on the RANGSDORF-ZOSSEN RR, appr 40 km S of BERLIN. In November 1944, it was evacuated to a hostel and two barracks in BIRKENWERDER between BERLIN and ORANIEBURG. In the middle of February it was moved to a small boarding house, two km N of BAD ELSTER, and in early April to REITH in Winkel/Upper Bavaria.

Leit Stelle II Sued Ost was located at Stubenring 1, VIENNA; Leit Stelle II West at BAD EMS; and Leit Stelle II Ost near LODZ. In January 45 Leit Stelle II Ost was moved to BIRKENWERDER.

A supply depot for Leitstelle II Sued Ost was in MELK/Danube. In April 1945, it was moved to vic RIED (Upper Austria).

Caches.

In 1941, Amt Ausland Abwehr started burying sabotage equipment in occupied countries in anticipation of an invasion. This task was almost completed when Mil Amt was created in 1944.

Equipment and arms were packed in watertight crates, 40 - 50 kg each. Their locations were recorded as follows:

- a. In written descriptions
- b. On photographs taken from different angles
- c. On maps (usually 1:25,000) and situation sketches (1:1000 or 1:5000).

They were registered according to contents of crates and number of the location. (e.g. W325 = weapons (Waffen) at location # 325).

Three to four copies existed of each record. One copy was on file with the respective Leit Stelle II. For each operation the agents were instructed to memorize the details about one or more caches. Mil D was informed of the corresponding numbers.

C O N F I D E N T I A L

In January 1945 SCHELLENBERG issued an order that safeguards be taken against the capture of these records. All copies were withdrawn, packed in crates, and given to the Jagd Verbaende Fuehrungs Stab. SKORZENY saw to it that all records which were not essential were burned before he left HOF. The remainder was burned at SALZEURG and ANNABERG.

(6) Associated Organizations.

a. Kriminal Technisches Institut (KTI)

KTI was a part of Amt V, which was headed by O/Gruf NEEBE until his flight after the 20 July incident. O/ Fuehrer PANZINGER then took over Amt V. Standf HEES, the director of KTI, was an eminent criminologist, well known at international conferences on the subject before the war. Stubaf Dr WITTMANN was in charge of the Referat for chemistry and physics.

The principal work of KTI was the use of technical means for the solution of criminal cases. Since it was frequently called upon to investigate acts of sabotage in this capacity, it had amassed a considerable fund of experience, including enemy sabotage methods. In January 1944 a report was made to SKORZENY on the subject.

As part of the KTI facilities were available, SKORZENY persuaded WITTMANN to work on the first model of an English one-round pistol with silencer. The job was done unofficially because it appealed to WITTMANN's taste for tinkering. VI-F and a weapons factory in Czechoslovakia were also working on the project independently. Difficulties arose when SCHELLENBERG objected to the participation of KTI in the work of Amt VI.

KTI manufactured 10 to 20 Russian Nagau revolvers with silencers for the Jagd Verbaende, and also parts for the British silencer-equipped Sten gun. In January and February 1945 KTI participated in the development of the Nipolit unit charge (cf Annex V), and delivered 300 to 400 ampules of hydrocyanic acid to the Fuehrungs Stab of the Jagd Verbaende for suicide purposes.

b. Kommando der Kleinkampf Verbaende (KdK)

When Germany inherited the remnants of the Italian armed forces in November 1943 it came into possession of the special weapons of the Italian navy. the following types of weapons were taken over:

- (1) Meeres Kaempfer (swimmers)
- (2) Schweine (two-man torpedoes)
- (3) One-man explosive motor boats
- (4) Two-man torpedo boats

The special weapons were first placed under the direction of Abwehr but as the military personnel represented having the status of agents, they were transferred to the Navy as the KdK.

C O N F I D E N T I A L

Training and technical development was the responsibility of the Navy, which had retained the Italian personnel. Jaeger Btl 502 furnished personnel to be trained for operations. Under this arrangement Admiral HEYE, CO of KdK and SKORZENY, head of Jg Btl 502, were on an equal level. Frig/Kptn FRAUENHEIM was HEYE's C of S.

On HIMMLER's orders only convicted soldiers on probation were used at first. They had to participate in a three-to six-week screening course at the Leibstandarte Barracks, BERLIN-LICHTERFELDE, at the end of which 25%, 150 men per course, were selected for KdK training. One NCO from Jg Btl 502 was placed in charge of each group of six to eight men. Upon SKORZENY's insistence, the Sonder Einsatz Abt zbV was formed to recruit volunteers from all branches of the Wehrmacht (see IIR on RADL). In its first week it recruited 200 men.

Training was carried on at the following places:

- (1) VALDAGNO. CO Kptn/Lt WOLK. Beginners courses for Meeres Kaempfer, November 1943 to August 1944.
- (2) VENICE. Started May 1944. Personnel from Jg Btl 502 left in October 1944.
- (3) RAD TOELZ. Started in February 1944.
- (4) Diana Bad, VIENNA. From September 1944 to February 1945.
- (5) Lake Como and SPEZIA. Trained personnel for one-and two-man motorboats.

c. Kampf Geschwader (KG) 200

SKORZENY's first contact with KG 200 dates back to October 1943, when it was called Staffel GARTENFELD zbV, CO Maj GARTENFELD, and used as a transport unit for parachute operations. Obst HEIGEL took command in January 1944 and the unit was renamed KG 200. In April all special weapons of the GAF became part of KG 200. These included suicide bombs, remote-control bombs, gliders for special purposes, piloted V-1's, and Mistel Flugzeuge (pick-a-back planes). A Fallschirm Jaeger Btl zbV was also assigned to KG 200. It operated during the invasion and saw action with SKORZENY in Hungary in October 1944 and worked with Pz Brig 150 in the Ardennes offensive.

KG 200 flew missions for Amt Ausland-Abwehr and subsequently for Amt VI. Deep penetration missions were flown directly by KG 200 while frontline undertakings were carried out by air force units near the front. KG 200 was composed of two Staffeln, the first being the transport unit and the second incorporating the weapons of the GAF.

C O N F I D E N T I A L

Originally SKORZENI was in direct contact with KG 200, which was located W of BERLIN. As the fuel shortage grew worse, missions had to be limited and KG 200 assigned a liaison officer to the VI-S office in the Bernauer Strasse. Each mission had to be carefully planned and in a monthly conference of Amt VI and Mil Amt, SCHELLENBERG decided which missions had the highest priority.

The Luftwaffe Fuehrungs Stab allowed a certain amount of petrol to KG 200 which could be used at the discretion of the CO. KG 200 had the right to refuse missions if they were technically impractical. Detailed planning was done directly by the Jagd Verbaende or FAK and the Gruppen concerned. These Gruppen usually were attached to army groups and reported to HQ after completing operations.

b. Sabotage Operations

(1) Invasion Nets.

In the spring of 1944, VI-B, -C, -E, and -S were each ordered by SCHELLENBERG to organize invasion nets (Invasions Netze) for the purpose of sabotaging enemy supply lines in the event of an invasion. VI-S, lacking personnel for such groups, was to be helped out by the other Gruppen of Amt VI.

RADL denies that any invasion nets were formed by VI-S. However, early in 1944 Amt VI, and VI-E in particular, began making plans for nets, primarily to supply them with information in case the Balkans were occupied. Similar nets for sabotage purposes were contemplated by VI-S but failed to materialize because of lack of personnel and on account of personal difficulties between MANDEL and BENESCH (cf Annex III). All plans were abandoned in January 1945.

A typical instance of incompetence among the leaders is demonstrated by an incident which was mainly the result of BENESCH's failure to consult with MANDEL. BENESCH decided to send sixty Serbs, all Chetniks, into Serbia. He contacted LUBURICH, the leader of a gang of nationalist Croatian extremists. LUBURICH claimed to be willing to guide the group to Serbia via Croatia, but in December 1944 he had them all murdered near ZAGREB by his men. MANDEL would have known that LUBURICH was not to be trusted.

The operations of the invasion nets in each country are discussed in detail in Annex II.

(2) Operations by Agents.

Ninety-five percent of the operations by agents were initiated by the FAT's. Every German army normally had one Front Aufklaerungs Kdo II (FAK II) and each of its three corps had one Front Aufklaerungs Trupp II (FAT II).

C O N F I D E N T I A L

The FAK II on the Western front were subordinated to Leit Stelle II West fuer Front Aufklaerung; the situation was similar in the East and South East. Each FAK and FAT carried on continuous agent operations contingent with the situation. Trupps and Kommandos trained their own agents. It is estimated that 20 to 25 operations, each comprising one to five agents, were carried out monthly on the Western front. On the Eastern front appr 600 agents were committed during the last half of 1944, and 20 - 30 per month in the South East.

Missions.

Agent operations were usually aimed at disrupting the flow of supplies. Targets such as ammo depots and vital factories were attacked rarely and only with good agents.

Some of the operations, especially after June 1944, were aimed at the formation of resistance groups who could disrupt supply and communications. Resistance groups were to operate indefinitely, while agents had orders to return immediately upon accomplishing their missions.

The percentage of returning agents in the East varied according to the tactical situation from 15 to 50%. In the West the figure was between 30 and 40%.

Employment of Agents.

Important missions using good agents were carried out with the aid of the Luftwaffe. Parachute drops constituted 20 to 30% of the total number of missions.

Less vital missions which involved crossing the front lines and which had their objectives within 60 km of the MLR comprised 60 to 70% of the operations.

Stay-behind operations during a general retreat added up to 10 to 20%.

Reports.

Reports of returning agents were carefully studied. The central office, VI-Z, was informed in the case of new developments, such as new systems of police control, new means of identification, and new currency.

Monthly reports were sent from the Leit Stellen II to the Mil Ant D central office, which published reports on experience gained through operations and on sabotage material. Summary reports described the routine operations of FATs and FAKs by means of statistical tables. Only special operations were reported individually.

Plans for new operations, most of them involving long distances, were submitted to BERLIN where liaison with KG 200 was available. In case there was not enough fuel on hand, SCHEELENBERG himself decided the priority of the missions.

C O N F I D E N T I A L

Payment.

During their period of training agents were paid in accordance with their former incomes, on a scale ranging from RM 400 to RM 800 per month. They received bonuses of RM 2,000 to RM 4,000 per mission after their claims had been proved correct. For operations they were paid in the currency of the respective country at the rate of RM 1,000 for each four weeks.

Payments were made either from imprest funds by the Dienst Stellen, or by Amt II or VI-A from special funds authorized by SCHELLENBERG.

Contact Addresses (Anlauf Stellen).

The majority of these were parts of the I-nets or stay-behind groups of Mil Amt D. Usually cafes, restaurants, hotels, bicycle stores, and other public establishments were used. If no contact address was available in an area, operations were initiated for the purpose of establishing one (cf Annex IV).

(3) Association with Foreign Fascists.

a. French

The French Government with about 1,000 followers moved to Alsace-Lorraine in September 1944 and to SIGMARINGEN in October 1944. Amt VI maintained contact with it through the Beauftragter West of VI-B, Standf PICKLER. H/Stuf NOSSECK was appointed liaison officer to the exiled government by VI-B.

SKORZENY met DARNAND and DORIOT for the first time at a conference, arranged by Standf STEINLE, in the SS Gastehaus BERLIN-WANSEEE. DORIOT was backed by HIMMLER while DARNAND was favored by RIEBENTROP.

SKORZENY himself was impressed by DARNAND. The latter claimed to have 4,000 to 6,000 followers at his disposal. They were distributed throughout France, four to ten men in each small town, and were said to possess enough leadership ability to be used as the nucleus for a resistance movement. He offered his supporters as contacts and proposed that some be used as agents but insisted he be kept informed of their activities. It was agreed that an efficient resistance net could only be built up out of a political organization. DARNAND and DORIOT were asked to visit groups in training in order to maintain their influence and continue political indoctrination.

SKORZENY met DARNAND for the second and last time in January 1945 at a dinner in the Eden Hotel in BERLIN. He told DARNAND that he would not need more sabotage agents during the next two months. An adequate number, 60 to 80 men, had been obtained from the organizations of DARNAND and DORIOT and from the French Waffen SS Regt "Charlemagne". He wanted DARNAND and DORIOT to spend the following two months in preparing a thorough political organization among the White Maquis. Future sabotage operations were to be based on this organization.

C O N F I D E N T I A L

DORIOT, who was killed in an air attack in March 1945, intended to employ his force of 2,000 miliciens as a military organization. His political interests were limited and he preferred the role of an officer. He offered to furnish agents from his group on the condition that he retain control over them. He also requested especially that VI-S and Jagd Verband Sued West use only his agents and not German personnel.

The Jagd Verbaende and Leit Stelle II West at BAD EMS, needed French sabotage agents. Lt FRANK of Leit Stelle II West was ordered to keep in touch with DARNAND and DORIOT for the two agencies and VI-S, working with BICKLER and NOSSECK. They were to select Frenchmen suitable for sabotage and espionage, who were to be sent to screening camps and then to the various Jagd Verbaende and other interested agencies. Some of the volunteers went directly to Sued West and were used for military purposes (see also Annex IV).

Difficulties between GERLACH, CO of Sued West, and HELLMERS, CO of Leit Stelle II West, arose, when HELLMERS used agents.

No reports of activities were received in the Fuchrungs Stab, according to RADL, because of the semi-independence of Mil Art D and the independent operation of Jagd Verband Sued West.

b. Belgian

Both VI-S/4 and Jagd Verband Nord West had connections with DEGRELLE and in the winter of 1944 sent H/Stuf HOYER to confer with him. It was agreed that only people selected by DEGRELLE would participate in subversive activities in WALLONIA and that DEGRELLE would send a group of his followers to the school at NEUSTRELITZ. DEGRELLE did not keep the bargain but sent his men into divisions at the front and even drew personnel away from NEUSTRELITZ.

Van der WIELE had been recommended to HIMMLER and in the winter of 1944, HOYER conferred with him. As a result, only van der WIELE's followers were to be used for operations in Flanders and 30 Flenish women were to be trained as W/T operators by VI-S. They came to FRIEDENTHAL but with the exception of four or five proved to be unsuitable and were sent back by SKORZENY.

Since van der WIELE was recognized by only a minority of the Flenish people, no great activity by VI-S or the Jagd Verbaende took place in Flanders. One group of appr 30 people under U/Stuf BACHOT was located near GIESSEN, prepared to work in Belgium. Due to the rapid Allied advance, they presumably never became active and were probably captured.

C O N F I D E N T I A L

SKOPZENY and RADL claim not to know whether Leit Stelle II West had connections with van der WIELE or DEGRELE.

RADL does not believe that DEAT or MUSSERT worked with the Jagd Verbaende, Mil D, or VI-S.

Organization of the SS Jagd Verbaende

SUBJECT: The German Sabotage Services

DATE: 23 July 1945

1. The Territorialen Jagd Verbaende

The SS Territorialen Jagd Verbaende were subdivided into Cos., known as Jagd Einsatze, which were organized on a nationality basis, e.g. Jagd Einsatz Ungarn. The ratio of Germans to foreign nationals was supposed to be two to one. It was considered desirable for the German personnel to be able to speak the respective languages.

Detailed organization and strength were not strictly defined, and varied according to circumstances.

a. Fuchrungs Stab

The central HQ (SS Jagd Verbaende Fuchrungs Stab) was located at FRIEDENTHAL.

Its orders were to cover matters of principle only. The Fuchrungs Stab was to develop plans for organization and recruiting, which it then submitted to the central Reich agencies to obtain the necessary orders and authorizations. The actual recruiting was to be done by each Jagd Verband. Requests and orders from the Wehrmacht Fuchrungs Stab were received by the central HQ for dissemination to the Jagd Verband concerned. This afforded a unified chain of command without limiting the freedom of action necessary for the handling of situations arising at the front.

Organization of The Fuchrungs Stab

CO: O/Stubaf SKORZENY

Adjutant and liaison officer; Stubaf RADL

C of S: HStuf Von FOELKERSAM

Succeeded Jan 45 by O/Stubaf WALTER.

The C of S had direct control over all departments.

He was permitted to issue orders in SKORZENY's name.

I-a: HStuf HUNKE

O/Stuf SCHROETTER, deputy

U/Stuf WICHMANN, administrative officer

HStuf BESEKOW) in charge of agent operations

O/Stuf MEIER)

2 NCOs

1 Draftsman

The I-a department had charge of operations of the Jagd Verbaende and VI-S and the training program. It worked on plans for operations suggested by outside sources (e.g. HIMMLER or the SPEER Ministry).

It handled W/T and teletype messages and papers pertaining to tactical matters.

I-b: HStuf GERHARDT

HStuf UEBERSCHER, procurement of weapons and ammo (beg Jan 45)

1 explosives NCO

1 Draftsman

I-b was responsible for supply and motor transport for the Jagd Verbaende and VI-S. It also furnished Mil D with Nipolit.

Standard equipment was drawn by the Jagd Verbaende directly from army groups or armies.

I-b dealt with Mil D/T; the I-b of the EdE, Befehlshaber des Ersatz Heeres; the AHA, Allgemeine Heeres Amt; the Army, GAF, and Waffen SS ordnance departments; Gen EUHLE, the Quartermaster General (Q) of the Fuehrer Haupt Quartier; and with private firms engaged in the production of clothing, equipment, weapons, ammo, and explosives. Technical developments by Mil D/T, VI-F, ordnance departments, and private firms were followed.

The issue of equipment to Werwolf was handled by the department.

I-c: O/Stuf Dr GRAF
2 interpreter NCOs
1 Draftsman

I-c maintained liaison with the Wehrmachts Fuehrungs Stab and I-c GAF to keep abreast with the enemy situation.

The department evaluated the intelligence received from the Seehaus Dienst, an institution of the Foreign Office for the monitoring of foreign broadcasts.

Liaison was maintained with Mil Amt B and C.

II-a: O/Stuf GALLEN (also SKORZENY's asst adjutant)
Chief responsibility was the recruiting of new officers from the Wehrmacht and the Waffen SS. Liaison was maintained with the HPA (Heeres Personal Amt), Gen BURGDORF and Gen HELLERMANN; the personnel office of the Waffen SS, O/Gruf HERF and Brigf Dr KATZ; and the SS Hauptamt, O/Gruf BERGER.

II-b: HStuf WEISS (succeeded by O/Stuf STEINLEIN)
EM personnel.

III: Gaf PINDER
Judge Advocate.

IV-a: HStuf URBANEK

Normal tasks were the handling of rations, pay, clothing, and equipment.

Subordinate to I-b for extra equipment.

IV-b: HStuf Dr WETZ

Chief responsibility was the procurement and training of medical personnel for all Jagd Verbaende. The T/O called for two doctors per Jagd Verband.

A medical kit for special missions was developed.

Dr WETZ observed two sets of experiments conducted by Naval doctors, which were never completed:

A stimulant for personnel engaged in special operations containing Pervitin, Caffein, and Morphium enabled swimmers to attain a higher, more even standard of results.

A preparation obtained from algae increased night vision power eight to ten times while another derived from deep sea fish increased it forty times.

V (K): O/Stuf WEBER

Succeeded Feb 45 by HStuf MASLOW.

V (K) was in charge of the repair shop. For the procurement of vehicles he was subordinate to I-b.

V (K) also was in charge of drivers' training. Plans were made to train all Jagd Verband members to drive all types of vehicles.

VI: Standf BAYER

NSFO and special service officer.

b. HQ Units

The following units were directly under the Fuehrungs Stab. In March 45 it was planned to organize them into a HQ Bn (Stabs Abteilung) under Stubaf BLUMENTHAL.

HQ Co: CO, O/Stuf GALLENT, succeeded Feb 45 by Stubaf DRIEBHOLZ.

Composition: Fuehrungs Stab personnel, a guard Plat, a dog Sec, and a horse Sec. Total personnel 200.

Sig Co: CO, H/Stuf STRECKFUSS. HStuf KALWEIT was responsible for the Jagd Verbaende communications net and the procurement of sig equipment.

Composition: The W/T and telephone operators and teletypists. Total Personnel 250.

Primary task was the operation of communications for Fuehrungs Stab, Jagd Verbaende, VI-S Aussen Stellen, Mil Amt D Leitstellen, and the schools. W/T communications with operational groups were handled by the Jagd Verbaende.

Work Shop Co: CO, O/Stuf WEBER (Also V (K)). Avor 98 men, in three platoons. A weapons workshop was attached.

Service Co: CO, O/Stuf STAFFER (after Jan 45) who was responsible to the I-b. Total Personnel avor 80 men.

c. Jagd Verband Ost

CO, H/Stuf von FOELZERSAM (also C of S Fuehrungs Stab)
Deputy CO Stubaf HEINLE

According to SKORZENY the approximate strength of Jagd Verband Ost was 800 men composed as follows:

400 Germans	50 Latvians
200 Russians	30 Lithuanians
80 Estonians	50 Poles

RADL estimates the strength of the entire unit as only 200 - 300 men.

C O N F I D E N T I A L

The units stationed in HOCHENSALZA were almost completely destroyed in the Russian attack of 20/21 Jan 45. Remnants returning to FRIEDENTHAL included appr 10 Germans. Among them were Stubafs Dr PECHAU and ROGER, U/Stafs RINTE, TIETJEN, ZUR LUEBELN, and MUELLER beside 40 Russians, and 20 - 30 men of Jagd Einsatz Baltikum.

Stubaf AUCH was charged with the reorganization of the Jagd Verband. He received as reinforcements 40 - 50 Russians (probably VLASSOV men) and appr 50 Germans.

Jagd Einsatz Baltikum Made up of Estonians, Latvians, and Lithuanians, was formed around a nucleus of Baltic V-men whom Stubaf Dr PECHAU of VI-S/4 had gathered while he was with the Bds, RIGA. PECHAU joined Jagd Verband Ost in October, November 44.

Einheit GIEL A Russian Jagd Einsatz made up of 20-30 Germans and 60-70 Russians (SKORZENY refers to this unit as Jagd Einsatz Ost 2). Stationed near TRAUTENAU (Czechoslovakia). GIEL's staff included a female pharmacist who had large stock of narcotics. SKORZENY states they were issued to operational groups.

d. Jagd Verband Sued Ost

CO, O/Stubaf BENESCH.

The strength of Jagd Verband Sued Ost is estimated by RADL at 800 men, by SKORZENY at 2000 men. SKORZENY analyses its BRANDENBURG contingent as follows:

Streif Korps Kroation	80 men
Streif Korps Slowakei	80-100 men
Streif Korps Rumacien	60 men
Misc BRANDENBURG personnel	80-100 men

The head of Streif Korps Kroation, Hptm (now O/Stubaf) BENESCH, became CO Jagd Verband Sued Ost. In September 44, he left KRALJEVO for JAIDHOF near KREMS/ Danube in order to establish his Fuehrungs Stab there. Part of his Streif Korps went with him.

The remainder was organized as Jagd Einsatz Kroation under O/Stuf SCHLAU in the vicinity of ZAGREB. Jagd Einsatz Ungarn, CO O/Stuf KIRSCHNER and Jagdeinsatz Slowakei CO U/Stuf PAWLOWSKI were organized in the respective countries. Jagd Einsatze Rumacien, Bulgarien, and possibly Serbien were organized and remained in JAIDHOF.

Jagd Einsatz Donau: CO, H/Stuf PFRIEMER (formerly with Donau Schutz). In September 1944 the swimmers of the Sonder Einsatz Abteilung were withdrawn from Naval training camps in BAD TOELZ, VALDAGNO, and VENICE. Together with 30-40 picked men from the Donau Schutz, a counter sabotage organization of Leit Stelle II Sued Ost they were formed into Jagd Einsatz Donau. CO U/Stuf SCHREIBER was in charge of the swimmers.

e. Jagd Verband Sued West

CO, H/Stuf GERLACH, formerly CO Kampf Schule FREIBURG.

The strength of Jagd Verband Sued West is estimated by RADL at 120-130 men, by SKORZENY at 600 men.

Its BRANDENBURG contingent is analysed by SKORZENY as follows:

Additional personnel was recruited from army replacement brs and from foreign Waffen SS units.

SKORZENY and RADL disclaim a detailed knowledge of the organization. For a short time the Fuchrungs Stab and two Jagd Einsaetze for operations in France (designation unknown) were stationed in FREIBURG im BREISGAU. They moved to Kloster TIEFENTHAL WIESBADEN in September 1944. One of the French Cos was commanded by O/Stuf HONFELD.

Jagd Einsatz Italien. CO, O/Stuf SOELDER, was stationed in VAL MARTELLO nr MERAN (South Tyrol).

f. Jagd Verband Nord West

CO H/Stuf HOVER, Succeeded Feb 45 by H/Stuf DETHIER. No BRANDENBURG personnel was available for Jagd Verband Nord West. Its strength is estimated by SKORZENY at 400 men. RADL states that the unit never got beyond the recruiting stage with an estimated personnel total of 60-70 men.

The Fuchrungs Stab was located in NEUSTRELITZ. There was a Jagd Einsatz Flandern and a Jagd Einsatz Wallonien. The activation of Jagd Einsaetze Holland and Daenemark was also planned.

2. Jagd Verband Mitte

Jagd Verband Mitte was stationed at FRIEDENTHAL. It was a purely German Bn kept in readiness for special operations:

(cf Operation Panzerfaust ANNEX IV). Administratively, the Sonder Einsatz Abteilung zbV (which recruited for the KdK) was part of it.

The strength of Jagd Verband Mitte is given by SKORZENY as 800, by RADL as 400 men. It was organized in three Cos. The nucleus of its personnel was Jaeger Btl 502. Its approximate composition was as follows:

60% from the Army
20% from the Waffen SS
15% from the GAF
5% from the Navy

Jagd Verband Mitte became part of Div SOHWEDT committed under SKORZENY's command on the Oder front on 31 Jan 45.

Tk Co Because of the difficulties he experienced in activating Pz Brigade 150, SKORZENY decided to have a Tk Co at his constant disposal. Since no foreign nationals were involved it was to be part of Jagd Verband Mitte.

H/Stuf GIRG activated the Co nr VIENNA because important tank factories were in the vicinity. Personnel was drawn from the 10 Pz Div Reol Regt, MOEDLING.

In early January 45 when the situation became critical in East Prussia, 50 men from the Co were ordered to be committed. In the middle of Jan the remainder was ordered to FRIEDENTHAL.

Late in January GIRG departed for East Prussia with a second group of 50 men. He was stopped en route by the CO of DANZIG and sent on an operation in Poland without SKORZENY's knowledge or consent.

3. Fallschirm Jaeger Btl 600

SS Fallschirm Jaeger Btl 500 was commanded by H/Stuf MILLIUS. It had just returned from operations in Yugoslavia, including an unsuccessful parachute attack on TITO's HQ, where it had been attached to XIII (?) Alpen Korps. It had also been committed for a short time on the Russian front. On HITLER's orders SKORZENY was put in charge in August or September 1944 and the bn became part of the Jagd Verbande organization.

The Bn was reorganized in NEUSTRELITZ. Its criminal elements were removed, and it was renamed SS Fallschirm Jaeger Bn 600. After unfit personnel was eliminated it had appr 250 men. New recruits came from the GAF.

Its ultimate strength is estimated by SKORZENY at 900 men, by RADL at 500. It was organized in three Cos. Because of petrol shortage only one Co could be trained as a para Co. The other two were glider Cos.

The approximate composition was as follows:

- 40% from the GAF (parachutists)
- 30% from the Army
- 30% from the Waffen SS.

Fallschirm Jaeger Btl 600 became part of Div SCHWEDT.

Final Disposition of the Jagd Verbaende

SUBJECT: The German Sabotage Services

DATE: 23 July 1945

Until March 1945 a rapid collapse of the fronts was not anticipated. By that time W/T contact between the Fuehrungs Stab and the various Jagd Verbaende had become difficult. No stay-behind plans had been made, except in the Balkans, and hasty make-shift preparations became necessary.

The last order from the Fuehrungs Stab to the Territorialen Jagd Verbaende stated that:

1. The individual Jagd Einsatze were not to retreat beyond their assigned areas of operations. Jagd Einsatz Ungarn, for instance, was to remain in Hungary unless ordered otherwise by the military commander of its sector.
2. They were to let the enemy pass, establish themselves as potential resistance groups, and await further orders.
3. Meanwhile they were to hamper communications and harrass supply lines as long as they remained close to the front.
4. If this order could not be carried out, they were to join regular combat units.
5. The Territorialen Fuehrungs Staebe were not to stay behind the enemy lines, but were to maintain W/T contact with the stay-behind groups if possible.

Due to the rapid progress of the war, SKORZENY does not know to what extent this order was carried out. The groups which are known to have stayed behind the lines are treated in Annexes III and IV of this report.

The following is the final disposition of Jagd Verband elements in German territory:

Fuehrungs Stab. In the middle of February, The Fuehrungs Stab was moved to HOF, Bavaria. From there it moved to ACHTAL nr TEISENDORF (W of SALZBURG) early in April.

On 25 April the staff was reduced in size, and established in a special train at PUCH nr SALZBURG. The remodeled HQ included:

A I-b department was established in BISCHOFSHOFEN. The Service Co and maintenance section under Stubaf BLUMENTHAL and UEBERSCHER joined 6 Pz Army.

Jagd Verband Mitte and Fallschirm Jaeger Btl 600. Both units were part of Div SCHWEDT which was committed on the Oder front bridge heads SCHWEDT, ZEMDEN, and BELLINGEN. SKORZENY lost contact with them early in April.

Jagd Verband Sued West. Jagd Einsatz Italia consisting of appr 120 Germans and 40 Italians was stationed nr BRIXEN in April.

The units stationed in TIEFENHILF are assumed to have gone East with the army corps to which they were attached.

Jagd Verband Nord West. HQ and 3 Co, consisting of appr 20 Dutch, 20 Danes, 15 Norwegians, 5 Finns and 50 Germans, remained in NEUSTRELITZ at the disposal of the local CO.

1 Co (Jagd Einsatz Flandern) under U/Stuf BACIOT was stationed near GIESSEN in March.

2 Co, understrength, was with Div SCHWEDT.

Jagd Verband Ost. In the middle of February, Stubaf ROGER took 60-70 Russians to BERLIN-SCHOENEWEIDE, where they remained.

Two groups totaling 140-150 men, led by Stubaf AUCH and U/Stuf RIEDL respectively, and one group of 20-30 men from Jagd Einsatz Baltikum under Stubaf Dr PECHAU, left for vic TROPPAU (Czechoslovakia) during the first week of April.

The remainder stayed in FRIEDENTHAL when RADL left on 14/15 April. H/Stuf GERNHARDT was to lead them into combat on the Oder front.

Einheit GIEL (Jagd Einsatz Ost 2) was attached to Army Group Mitte, S of BRESLAU.

Jagd Verband Sued Ost. HQ was in GFOEHL near KREMS/Danube in early April.

Jagd Einsatz Slowakei under U/Stuf PANLOWSKY was committed with IX Corps in early April.

Jagd Einsatz Runaenien under H/Stuf MUELLER was committed North of PRESSBURG.

Schutz Korps Alpenland. SKORZENY stuck to the following account of the Schutzkorps. When he observed the conditions in Upper Austria, where desertions were out of hand and entire units were withdrawing without proper authority, he suggested the organization of a 'stragglers' patrol to Gau Leiter EIGRUBER. For this purpose Schutz Korps Alpenland was formed. It consisted of the following seven groups with a total strength of appr 250 men:

Gruppe U/Stuf SCHUERMAN, nr ALTAUSSEE (Austria). Appr 30 men.

Invasion Nets in Allied Occupied Countries

SUBJECT: The German Sabotage Services

DATE: 23 July 1945

GREECE. Dienst Stelle 2000 and 3000, formerly belonging to VI-F, were placed under Stubaf Dr. BEGUS of VI-S. BEGUS' HQ were located in a private residence in ATHENS. He had a W/T operator in SALONICA and operated a sailboat for espionage purposes among the Dodecanese Islands.

Orders to activate the invasion net were received in spring or summer of 44 from H/Stubf BESEKCM of VI-S/4 and BEGUS went to BERLIN for instructions. The largest group was organized in ATHENS, comprising 20 to 25 men. Another was located in SALONICA with ten men and it is presumed that smaller groups were formed throughout the country, some of them having been taken over from the former Dienst Stellen. It is not known whether political groups were used. The two larger groups were in possession of W/T equipment and the entire system was centrally controlled from ATHENS, where contact was maintained with the Havel Institut.

In June 44 Dr. BEGUS was succeeded by O/Stubf NEBENFUEHR, a former Navy engineer in Italy sent by Amt VI-A. After the occupation of Greece, W/T contact with the net was established twice. When street battles in ATHENS began, the initiative came from sources other than the invasion net. It was reported that subsequently a great number of arrests had occurred which handicapped the work of the net. No operations were reported, and later NEBENFUEHR went to BERLIN and left only one German NCO in Greece.

ITALY. Dr BEGUS was transferred to Italy in June 1944. He organized an invasion net in the Po valley known as Operation Zypressc using personnel from Prince BORGHESE's Decima MAS Flotilla (renamed Decima MAS Division in the Spring of 1944). SKORZENY estimates its size at six to eight groups of two to three men each. They had no radio communications but presumably used the VI-B espionage net radio facilities. No reports of their activities were received.

BEGUS also supervised several operations of the Italian swimmers (Meereskaempfer). Two operations in TARANTO and one in NAPLES in the autumn of 1944 were directed against enemy supply ships.

In a small village (name unknown) nr VERONA, a school for agents was established in cooperation with Maj USLAR, Abwehr II and CO of FAK 214 (?). Assistance was also rendered by Amt VI-B's Italian representative, Stubaf Dr HIEGEL, who had three or four officers with him, and Jaeger Btl 502 which furnished seven men as instructors and cadre. The school was opened in June or July 1944 and in December 1944 moved to vic BRIXEN (South Tyrol).

Courses lasted two to three weeks and consisted of English and American identifications, infiltration tactics, and the handling of explosives. They were attended by five or six men and taught by NCO's. Upon completion of training, the men were used in operations aimed at Allied supply lines in the Appennines and the Po valley from September 1944 to January 1945, two to three men participating in each operation.

ROMANIA. Preparations for an invasion net in Roumania began in April 1944 with the recruiting of Germans living in Roumania. H/Stuf LIEBHART and H/Stuf MUELLER were in charge of the activities and responsible to BERGER of the SS Hauptamt. Both of them were Roumanian Germans. MUELLER was a businessman and a native of BUCHAREST and LIEBHART a landowner in Transylvania. They continued in their occupations, wearing both civilian clothes and uniforms.

Three or four groups of five or six men each were organized in the PLOESTI oil field area. Another five or six groups of four to six men each, were formed in Transylvania. Almost all group leaders had been officers in the Roumanian or German army. They were trained at SEEHOF and by VI-F in BERLIN.

JUGOSLAVIA. SKORZENY gives the following picture of the invasion net in Serbia and Croatia. It was organized from elements of the BRANDENBURG Div under Maj BENESCH. He had a bn of appr 300 Germans at his disposal in the vicinity of BELGRADE which in August 1944 was renamed Streif Korps BENESCH. In May 1944 H/Stuf MANDEL, a member of VI-F, was sent as liaison man to Unit VI-E and VI-S.

The net was to serve simultaneously as the invasion net of VI-E/3 against TITO.

The territory was divided into ten geographical districts. Seven of them were under control of Div BRANDENBURG, the remaining three under VI-S. In September of October 1944 all these groups came under Jagd Verband Sued Ost as Jagd Einsatz Serbien Croatia, CO O/Lt ROWOHL.

FRANCE. The invasion net had been organized by BESEKOW in the spring of 1944 when he made appr three trips there. The task of directing operations was assigned to O/Stuf HAGEDORN in September 1944. He worked in cooperation with the PARIS representative of VI-B, Standf BICKLER; and with the organizations of Leitstelle II West, consisting of one or two FAKs each having two to three FAKs. Jaeger Btl 502 sent O/Stuf NEUMANN and three French-speaking NCOs. NEUMANN, a Fw from Abwehr II, and two Uffz from SEEHOF served as instructors.

The invasion nets were centered in Normandy, Brittany, and PARIS. Organization LIT furnished 120 men in Normandy and Brittany and 400 in PARIS, in groups of four or five men. The group leaders had been trained at SEEHOF. There were two or three M/T transmitters, one of them in PARIS and another in Brittany.

BELGIUM. The invasion net was organized by Uffz VERSTRATEN and another man. Both had worked in Belgium for the Abwehr. The net was concentrated on the coast and near BRUSSELS. SKORZENY knows of at least 20 to 25 men belonging to the net who were trained at SEEHOF. Radio stations were established in BRUSSELS and ANTWERP.

After the invasion two attempts were made by Jagd Verband Nord West to establish contact. The operations were carried out by two groups from the Flemish Co, comprising two to three men each (see operation JEANNE).

NORWAY. Preparations for an invasion net in Norway started in October 1944. Jagd Verband Nord West furnished three trained Norwegian NCOs, who recruited about 40 men for training. This was done in cooperation with the BAT II operating in Norway. No radio communications existed

BALTIC STATES. When the invasion nets in the Baltic states were organized, difficulties arose from the request by the prospective members for a certain amount of political independence. With the consent of Alfred ROSENBERG, SKORZENY granted their request, but all privileges were later abolished by Gauleiter KOCH. This caused great resentment.

The organization was headed by an Estonian army officer, H/Stuf JANKAVS. He was joined in January 45 by a Latvian and a Lithuanian O/Stubaf, both political representatives of the SS Hauptamt. A Co of appr 80 Estonians, 50 Latvians, and 30 Lithuanians was trained by Jagd Verband Ost from October 44 until January 1945.

The invasion net as it was established in Estonia comprised only 20 to 30 men. At the end of January, after parts of the Baltic states had already been lost, three groups were sent to Estonia, one to Latvia, and one to Lithuania, each composed of two or three men. JANKAVS remained behind the lines and was last heard from in April or May 1945.

Individual Operations (Unternehmen)

SUBJECT: The German Sabotage Services

DATE: 23 July 1945

1. Operations in the West.

Operation PETER

In December 1943 or January 1944, HITLER told RIBBENTROP and HIMMLER that Danish Resistance activities had become intolerable. Standf MILDNER, Bds Denmark, was unable to cope with the situation because the Danish police not only failed to assist him but cooperated with the resistance movement. HITLER ordered terror to be fought with terror, believing that the Danish people would then force the police to take strict counter-measures against all acts of terrorism. Standf MILDNER could not carry out these orders. He was short of personnel and his men were not trained in the handling of demolitions. Moreover, they were so well known in Denmark that they would be recognized immediately, which would defeat HITLER's purpose. The HSSFF confessed that the situation was out of control and that he was unable to offer any help or advice.

HIMMLER therefore ordered members of the Sonder Lehrgang ORANIENBURG, who were thugs experienced in the use of explosives, to be transferred to Standf MILDNER's staff. RADL emphasized that it should be possible to verify the fact that the persons sent from VI-S were members of the Sonder Lehrgang ORANIENBURG because the Sonder Lehrgang was in existence before SKORZENY took over VI-S. RADL, however, failed to mention one known member of the operation, who is not a member of Sonder Lehrgang ORANIENBURG. He claims to have sent only an interpreter, 60 years of age, to Operation PETER, in February. This man had no connections with the SD but was from the Luftwaffe and had relatives in Denmark whom he wanted to see.

RADL states that Amt IV was able to provide only the leader for the expedition, Stubaf NAUJOCKS (PW), who had been investigating black market activities for Bds Belgium. NAUJOCKS for some reason did not take part in the actual operation.

H/Stuf von FOELKERSAM selected the men from VI-S and sent them to COPENHAGEN. RADL remembers the following names:

U/Stuf PETER
O/Schrf Fritz HIMMEL
O/Schrf HUF
U/Schrf GLAESNER
U/Schrf Hans HOLZER
U/Schrf RENNER or ROEMER

The necessary materials were supplied by VI-F, while papers were issued by the Bds Denmark. All members had aliases in Denmark but these were not known to VI-S. From February to August 1944, reports on the operation were submitted every two months. One copy was sent to Amt IV and one to Amt VI which was read by SCHELLENBERG, SKORZENY, RADL and von FOELKERSAM. The reports were not signed by PETER. Why the operation was called "PETER" was not known to RADL and the fact that U/Stuf PETER was involved appears to him to be a coincidence.

In July 1944, Amt IV compiled a report on the Danish situation for HITLER. This report stated that the number of "Danish acts of terrorism" was six to eight times as large as PETER's acts. On the other hand, figures given by R.DL show that attempted or actual assassinations by the Danish Resistance numbered 30 to 35, while PETER's numbered eight to ten; Danish attacks on industry 90 to 95, PETER's 15 to 18; attacks on public gatherings by the Danish Resistance 20 to 25, and by PETER 30 to 35. R.DL prepared a memorandum for Amt IV, signed by SKORZENY, to the effect that VI-S should be kept out of these matters, and that the responsibility should be borne by Amt IV.

In August, Amt IV sent an expedition for similar purposes to Denmark, consisting of about ten men commanded by Stubaf PHILIPP. One of the members was U/Stuf ISSEL, who may have come from Amt I.

In September the VI-S men returned. Two reports of their activities in Denmark were sent to VI-S/L. R.DL did not read the reports, which went directly to SCHELLENBERG.

The activities of the Danish Resistance, aided by the British, were so intense that by the end of 1944 the counter-terror had become ineffective. R.DL states that the Danish Schalburg Korps, composed of Danish Waffen SS, also committed acts of terrorism in Denmark. They were said not to have had any official connection with the BdS or the HSSPf.

Projected PETAIN Kidnaping. In addition to the account of the operation in IIR-R.DL 12 AG dated 4 Jun 45, SKORZENY mentions the following members of the operation:

The troops taking part in the operation were quartered on the VICHY airfield and patrolled the roads eight to ten km from the center of the town of VICHY.

Operation CHARLIE.

This operation was carried out in September and October 1944 on orders of Brigf SCHELLENBERG and planned by O/Stuf HAGEDORN and H/Stuf BESEKOW. The agent involved was O/Stuf NEUMANN @ NEBEL.

His mission was to establish contact with and to organize the LIT group in PARIS, to locate a drop area for supplies, and to establish a new Anlauf Stelle (contact address). NEBEL was to cross the front lines near BELFORT. There was to be no W/T communication and upon completion of the mission he was to return.

After an absence of about eight weeks NEUMANN returned by way of the front lines. According to his report, the efficiency of Allied counter intelligence precluded any large scale activities in France. Little was left of the LIT group and no old contact address remained. A new contact address was established in a Southern suburb of PARIS and a drop area for supplies was found nearby.

Operation CHARLEMAGNE.

This operation was carried out by Leitstelle II West in November

and December 1944. Four or five groups were sent out, one to the Langres plateau, one into the Rhone valley, and one into the vic of VICHY.

The purpose was to establish contact with the White Maquis. Agents were recruited by Lt. FRANK through the French government at SIGMARINGEN. Leitstelle II West operated a W/T station with which contact could be made when necessary.

Neither names of agents nor the contact address are known. It is believed that followers of DARMAND and DORIOT were used. Results of the operations are unknown.

Operation Jeanne. Henriette

This operation was carried out by VI-S/4 and Jagd Verband Sued West, supplemented by personnel from Jagd Verband Nord West. It took place from November 1944 until January 1945 and was directed by BESEKOW, with HAGEDORN handling administrative details.

The mission was to establish contact with the I-net in Belgium. Two groups were sent out, one consisting of two Flemings, one of them a W/T operator, and the other of two Flemings and one Flemish woman W/T operator. The Flemings were furnished by the Flemish Co of Jagd Verband Nord West and remained in Belgium nr LIEGE & ANTWERP. None of their names are known. Communications were maintained with them by the W/T station of VI-F/H.

Both groups reported that nothing remained of the I-net and that they were waiting for supplies and personnel to be furnished by the Flemish Co of Jagd Verband Nord West.

Operation HENRIETTE. Jeanne

Neither MADL nor SKORZENY knew details of this operation, other than that BESEKOW probably was connected with it.

Operation TOTO.

This operation was carried out by VI-S/4 and Jagd Verband Sued West in December 1944 by order of the Wehrmachts Fuehrungs Stab under the direction of O/Stuf HAGEDORN.

The mission was to attack the pipeline running N from MARSEILLE by means of explosives and incendiaries and to attack fuel dumps near the front lines. Operations were to take place behind the front lines in the Alsace area and in the Rhone valley. Four groups of five to seven men each were sent out. Upon completion of the mission they were to join the White Maquis of the I-net in France; names of the participants are not known. It was known, however, that one fuel dump in the front area was blown up.

No W/T equipment was provided.

Operation SCHLANGE.

This operation was carried out in December 1944 by VI-S and Jagd Verband Sued West on orders of the WFueSt and in cooperation with the I-c of 5 Army. O/Stuf HAGEDORN was in charge of the four or five groups, comprising five to seven men each.

The mission was the destruction of the pipeline running E from LE HAVRE by means of explosives and incendiaries, and attacks on fuel and ammo dumps in the area facing the 5 Army sector. Personnel was to return if possible or to join the White Maquis.

Neither names nor results of the operation are known.

Panzer Brigade 150.

At the end of October 1944, SKORZENY was informed of the plans for the Ardennes offensive by HITLER and Gen/Cbst JOEL at the Fuehrer Haupt Quartier. He was ordered to activate Pz Brig 150 with O/Stubaf HARDICK as CO.

The mission of this unit was to seize the bridges across the Meuse, to operate as shock troops, and take advantage of the element of surprise. It was activated at the Truppen Uebungs Platz (maneuver area) at GRAFENWOHR in November and was composed of the following elements:

- (1) Approx 1000 volunteers from the army, navy, GAF, and Waffen SS of whom 120 officers and 600 men formed a Commando Co and the rest were divided among other units of the brigade.
- (2) Two Cos of Jagd Verband Mitte-360 men
- (3) Two Cos of Fsch Jg Btl 600 - 380 men
- (4) Two Bns of KG 200 - 600-800 men - GAF parachutists
- (5) Two Panther Tk Cos - 240 men
- (6) Three Pz Gren Cos - 520 men
- (7) Two AT Cos - 200 men
- (8) One Hvy Mort Co - 100 men

All figures given above are approximate. The total strength of the brigade was 3000 men, of whom 300 to 400 were dressed in American uniforms. When the unit was committed, all non-combat elements remained at Truppen Uebungs Platz W.L.H.N, S of COLOGNE, reducing the brigade to a combat strength of 2400 men. Before the offensive, in early December SKORZENY had made a tour of the various army HQs on the Western front in order to familiarize himself with the plan of action.

At the start of the operation, three or four recon teams of three men each were sent out, dressed in American uniforms and equipped with jeeps. Two sabotage teams of five men each in American uniforms, driving 3/4 Ton trucks, were sent against enemy-held bridges. One recon and one sabotage team came back. It had been planned to commit 300 to 400 men on similar missions but this proved impossible when the offensive did not sustain itself.

The losses of the Pz Brig, equally distributed among its component units, were 20% dead and wounded. When O/Stubaf HARDICK was killed during operations, SKORZENY assumed personal command of the unit.

Operation SILBERFUCHS.

After the German retreat from Finland, it was decided to organize a resistance movement in Norway. Jagd Verband Nord West sent an U/Stuf whose name is unknown to Norway for this purpose. He was unsuccessful and VI-S requested Amt I to supply someone familiar with Norway to take charge of the operation. Bds OSLO sent H/Stuf ROMMEICK to FRIEDENTHAL for training. He then returned to Norway to recruit agents, and is believed to have sent 20 to 30 men to Kampf Schule NEUSTRELITZ. ROMMEICK's recruiting activity in Norway was called Unternehmen SILBERFUCHS.

At the time of the German surrender, the resistance movement had not been organized.

Operation HORNFIELD.

This operation was carried out by Jagd Verband Sued West in January 1945 on the Alsatian front. O/Stuf HORNFIELD, two NCOs, and one EM, all of 2 Co Jagd Verband Sued West, participated in the mission of destroying a transformer approx ten km behind the front lines. After two and one half days during which they placed the explosive charge and observed enemy activity, the group returned. Through the use of a time delay the transformer was blown up during the third night.

2. Operations in the East

Operation Panzerfaust .

It was known to the Germans that HORTHY had established contact with TITO in an attempt to negotiate a separate peace with Russia. In September 1944 SKORZENY got orders from HITLER and HEIDLER to plan HORTHY's abduction. For this purpose a force was placed at his disposal, consisting of:

- (1) One reinforced Co Jagd Verband Mitte (250 men)
Acting CO was O/Stuf MANN
- (2) One reinforced Co of Fallschirm Jaeger Btl 600
(250 men). Acting CO was O/Stuf MARCUS.
- (3) Two parachute Cos of KG 200.
CO was Maj SCHLUCKEBIER.
- (4) Four Cos of officer candidates from the WIENER NEUSTADT OCS
(Appr 700 men)

This force was to operate in BUDAPEST under command of Gen d Inf BECK, former defender of RHODES, to whom SKORZENY was subordinated.

Organization took place in VIENNA. The following Fuehrungs Stab officers took part:

H/Stuf Von FOELKERSAM (C of S)
~~H/Stuf RUDL (deputy C of S)~~
O/Stuf GILBERT (deputy)
U/Stuf LOCHNER (administrative officer)
H/Stuf HUNKE (CO of Co Jagd Verband Mitte)
H/Stuf MILIUS (CO of Co Fallschirm Jaeger Btl 600)

In addition, SKORZENY could dispose of elements of the 21 Hungarian SS Div, the 106 and 108 Tk brigades and picked members of the GAF stationed in Hungary.

SKORZENY took up residence in BUDAPEST in the beginning of Oct, and had his office in Gen BECK's HQ, while the troops were quartered in the suburbs.

In BUDAPEST he met the Graf PFEFFER-WILDENBRUCH, Commander of the Waffen SS for Hungary; O/Gruf WINKELMANN, the HSSPf for Hungary; O/Gruf Von Den BACH-ZELEWCKI, who was sent by the Fuehrer Hauptquartier; Standf KESCHGE, BdS; and the Ambassador to Italy, Dr RAHN.

On 16 Oct orders came from Ambassador VEESENMAYER to Gen BECK to start the action. SKORZENY with a small force arrested HORTHY's son, a friend and two TITO representatives.

Several high German officials such as PFEFFER-WILDENBRUCH, VEESEN-MAYER and the German military attache were on the Burg Berg. HORTHY ordered the Hungarian troops to be concentrated around the Burg Berg and made a radio speech asking for a separate peace. SKORZENY then threw a cordon around the Hungarians. HORTHY received an ultimatum, expiring

at 0600 hrs the next morning, stipulating that the peace offer was to be officially revoked and the troops withdrawn.

After its expiration, SKORZENY broke through with a Tiger Tk Co and a Co of Fallschirm Jaeger Btl 600 and took the Burg Berg. HORTHY, however, had already surrendered to PFENNER-WILDENBRUCH. The next day HORTHY was taken by special train to MUENCHEN.

Operations FREISCHUETZ I - IV.

These operations were undertaken in order to contact the isolated Kampfgruppe SCHERHORN, composed of 2500 men, in the MINSK area. Four groups of 10-15 men were organized by Jagd Verband Ost and the Jagd Verband Fuchrungs Stab on direct orders from HIMMLER. Each group was under command of a German officer, but had also two Russian members. They were equipped with W/T sets.

The groups set out in Oct/Nov 44 from East Prussia and were dropped near MINSK. Group I and II were to march Eastward in search of Obst/Lt SCHERHORN and his men, while Group III and IV searched Westward. One group under U/Stuf SCHIFFER found SCHERHORN after three weeks. Originally they planned to return by land, but this was impossible because the men were too exhausted. Instead, arrangements were made to supply the party by air and actually rations, medicine and ammunition were dropped 8 or 10 times. The evacuation of the force by air from former partisan airstrips had to be abandoned in view of the Russian offensive against East Prussia. It retired according to orders toward Germany in two advance parties and two main bodies (Nord and Sued). Last radio contact occurred late in January or early February 1945.

Of the other groups, two were never heard of and one returned to Germany.

Operation SONNENBLUME.

The purpose of this operation was to establish contact with the Ukrainian Nationalist Movement, UPA, in order to determine how many Germans were fighting with UPA bands and to report on the guerilla situation in the Ukraine.

The operation was started by Mil Amt in Sep/Oct 44, under command of Hpt KIRN, a competent young officer who had been personally authorized by HIMMLER to deal with UPA. KIRN was CO of a FAK Trupp, 202 or 203, which belonged to Lt Stalle II Ost fuer FAK. He had some 15 men including two officers, eight NCOs and three Ukrainians.

UPA had strong groups operating against the Russians throughout the Ukraine. Some of them comprised as many as 3000 men, tying up whole divs. UPA distrusted the Germans' who had not kept their promise, given in 1941, to form an independent Ukrainian state. Instead, their leader in BERLIN, BANDERAS, had been arrested with his followers.

After the German retreat from the Ukraine, many German soldiers stayed behind in pockets. Some of them were captured and turned over to UPA, others voluntarily joined UPA's ranks. UPA had clandestine W/T and personal contact with members of the Ukrainian movement working in labor camps in Germany. Apart from this, UPA established connections with Germany through KIRN's organization in the Ukraine.

UPA's condition for cooperating with the Germans in resisting Soviet troops, was the liberation of BANDERAS and his followers. RADL presumes that this condition was presented to the Germans through the clandestine W/T service. At first Amt IV refused, for fear that this might result in uprisings of the Ukrainians in German labor camps, but in Oct 44 it consented to release BANDERAS at a pre-arranged place.

In October 1944 KIRN and his men went through the front lines to the Western Ukraine. Here he made his survey of Germans fighting with UPA and conferred with the leaders of the movement. Large numbers of German officers and NCOs were accounted for. In Nov he was picked up by a Ju 52 and returned to Germany. This terminated operation SCHEIBLUE. From then on KIRN maintained contact with UPA both by W/T and by courier.

UPA's efforts were not motivated by sympathy for Germany, but by hate of their common enemy. Any illusions raised by Germany's repeated assurances of help to create an independent Ukrainian state, were shattered when VLASSOV issued the Prague Manifesto. Germany apparently backed VLASSOV's ideas of a greater Russia, which were incompatible with Ukrainian independence. RADL points out that VLASSOV was in a difficult position. If he had promised Ukrainian independence, he would have lost whatever backing he still had for a greater Russia.

KIRN's efforts to support UPA were interrupted in Jan 45 when the Russians advanced and he had to retreat with his Kommando to Silesia, where he attempted to build up resistance against the Russians with a group of nationalistic Poles.

Operation LANDFRIED.

When Roumania was lost in Sep 44, HITLER ordered this operation, which is also known under the name Sonder Unternehmen GIRG. A member of Jagd Verband Mitte, W/Staf GIRG and 30 men supplied the Germans in Transylvania with weapons, assisted them to return to Germany with their families, blew up bridges and obstructed passes in the Carpathians, and made a reconnaissance mission. They operated behind the Russian lines, in Russian, Roumanian and Bulgarian uniforms, according to the territory.

Operationally the undertaking was under command of O/Cruf FLEPS. In Jan/Feb 45 fifty men were committed, who operated 700 km behind the lines. They were divided into an eastern group, a western group and a central group. The first obstructed three passes and located appr 2000 men from the FLOESTI AA batteries in the vicinity of KRONSTADT, of whom 250 were brought back. The western group brought back German residents and collected intelligence.

The central group was under command of GIRG. It placed demolitions in the Rotenturm Pass, S of HERRMANNSTADT and observed Russian preparations in that vicinity. On one occasion they marched for about 15 km in a Russian column. They were discovered and condemned to death. GIRG however managed to escape from the firing squad and to reach the German lines. He submitted a report containing valuable information on Russian order of battle and was awarded the Ritterkreuz.

In January GIRG came back from another operation in the DANZIG area. He was arrested by the commandant of the city of KOLBERG on suspicion of being a SEYDLITZ sympathiser and was sentenced to death. When he offered to defend the city at the most vulnerable spot, the commandant became convinced of GIRG's political reliability and released him. He returned to FRIEDENTHAL in early Mar and joined SKORZENY.

Operations GEMSBOCK I-VI.

Between October and December 1944 six operations took place in NW Roumania, where many Germans were settled. The purpose was to establish contact with the invasion net and the groups were equipped with W/T sets. Each group consisted of between three and five men mostly Germans from Roumania, drawn from Jagd Verband Sued Ost, within which there was an SS Jagd Einsatz Rumanien under O/Staf MUELLER.

All but two members of one group were captured by the Russians shortly after landing.

Operations STEINBOCK I-III.

These took place between Oct and Dec 44 to strengthen the Iron Guard. They were carried out in the territory north of BUCHAREST. There were 3 to 5 men with W/T equipment in each group.

Operations REGULUS I-VI. Leit Stelle II Sued Ost undertook six operations between October and December 1944. The groups were dropped by parachute to establish contact with the Roumanian Army and the resistance movement. Small groups were used, consisting partly of German EM, partly of Roumanian volunteers.

The undertakings were successful.

Operations FORELLE I-II.

In October 1944 Jagd Einsatz Donau of Jagd Verband Sued Ost made attempts to make traffic on the Danube unsafe by blowing up bridges and shipping. The operation, including swimming saboteurs, was under command of O/Stuf STANZ and U/Stuf WOUTERS, who had a ship called the "WALTER", equipped with radio, arms and ammunition. It was found impossible to attack the bridges because they were seized too quickly by the Russians. A limited success was attained by blowing up a ponton bridge with the aid of floating mines, and by sinking appr 10,000 tons of shipping with magnetic charges.

FORELLE II was an operation by the same unit to break through to BUDAPEST and deliver 600 tons of food and ammunition. It took place on the night of 31 Dec 44, and although the "WALTER" ran aground on a sandbank 20 km from BUDAPEST, O/Stuf STANZIG succeeded in loading the goods onto a small cargo ship and transporting them to BUDAPEST. W/T communication was maintained with the "WALTER" for five days, after which there was complete silence. A special patrol sent out by Jagd Verband Ost to find out what had happened reported that the ship had been abandoned.

Operations SCHLANGE.

These operations of Jagd Verband Sued Ost in Serbia all had names of snakes, such as SANDVIPER, BLIND-SCHLEICHER, KREUZOTTER, HORNVIPER, and RINDELWATTER. According to RADL there were some ten groups of 20 men each, who were to allow themselves to be overrun by the Russians and then attempt to establish W/T contact with the staff of Jagd Verband Sued Ost. He thinks that some of them were connected with MIHAILOVICK.

The groups were to maintain radio silence for some four weeks and until April 1945 no W/T contact had been established.

Operations ABENDSTERN, FIXSTERN, POLARSTERN.

All these operations were organized by Jagd Verband Sued Ost in Hungary. There were several more of these undertakings, all bearing names of stars. The largest was ABENDSTERN which was carried out in Nov 44. It comprised appr 100 Hungarians and 10 German instructors who were left behind the lines in the vicinity of SZEGED to perform sabotage activities against enemy supply lines. No reports were received.

SK ORZENY mentions the following "STERN" undertakings:

In October 1944 ten men were left behind the enemy lines in the BANAT. No reports were received, as the group did not have W/T sets.

In November/December three or four patrol operations took place near Lake Balaton (Platten See). It is known that an ammunition and a POL dump were blown up.

In January two recon missions were carried out S of Lake Balaton.

In March, appr 80 Hungarians stayed behind in the BAKONY WALD, they maintained W/T contact with the Honved Ministry.

In March, two groups of 10-12 men each were left behind the lines S of Lake Balaton. No reports were received.

Operation STIEGLITZ.

This operation was originated by Jagd Verband Sued Ost in the fall and winter of 1944 and early 1945, involving a resistance movement in Hungary. No details are known.

Operation WILDKATZE.

Jagd Verband Ost made plans with W Fue St Ost and Fremde Heere Ost for eight to ten operations in the Baltic States and Poland. However, only the first one materialized. Its purpose was to harass communication lines and to round up German stragglers. In February 1945 Stabaf Dr PECHAU and some ten to fifteen men were dropped by parachute SW of LODZ. The results are not known, as none of them returned and as they had no W/T equipment.

Unternehmen WILDKATZE was the precursor of Jagd Einsaetze BALTICUM I and II which undertook operations S of BRESLAU with basically the same purpose. SKORZENY can not remember having seen any reports on these undertakings.

Operations by Dienst Stellen 2000 and 3000.

(See IIR 12 Agp-RADL dated 4 Jun 45.) No actual operations are known, except that attempts were made to work in Syria and Palestine with the aid of Greek merchants.

Operation THEODOR.

(See IIR 12AGp- RADL dated 4 Jun 45.)

Projected Attack on Russian Industry.

In Nov 43 plans were made to impair the Russian war production in the Urals. SKORZENY believes that SPEER was the originator of the idea. The SPEER Ministry put special emphasis on the destruction of the blast furnaces of M. G. ITOGORST. SKORZENY was of the opinion that an attack on the power system which supplied a vast net of very large plants would be more effective. He objected to the original plan to use Jaeger Btl 502.

When Army Group Mitte collapsed in Jun 44 nr MINSK, the bases for the planned operations were lost. New detailed plans were worked out for an attack against the MOSCOW industrial regions, but were never used.

Technical Sabotage Information

SUBJECT: The German Sabotage Services

DATE: 23 July 1945

The development and manufacture of sabotage equipment and special weapons were carried out by VI-F and Mil Amt D/T. The individual components of sabotage material were often purchased from private firms.

VI-F occupied two houses in Douglas Str, BERLIN-SCHMARGENDORF, with workshops and laboratories, and in the spring of 1944 took over a part of FRIEDENTHAL, which was closed off from VI-S and to which access could be obtained by special permission only. VI-F also had several camps in the neighborhood of BERLIN.

Mil Amt D/T had workshops and a camp at an abandoned factory at QUENZ and in barracks on the factory grounds.

In February and March 1945 standard packages (Einheit Paketen) weighing approx 2 kg were made up and distributed as follows:

To Wervolf	500 packages

Jagd Verband Sued Ost Jagd Verband Ost (for Unternehmen Wildkatze)	200 packages 200 packages

In each package were:

- 4 All-purpose Nipolit Charges
- 2 Nipolit hand grenades
- 1 Nipolit pressure-release bomb
- 1 Nipolit incendiary bomb (hexagonal)
- 1 ZZ 42 push-pull igniter
- Safety fuse
- Detonating fuse
- Blasting caps
- GAC delays

SKORZENY's knowledge of German sabotage material is rather limited. he has, however, mentioned certain items that were hitherto unknown.

1. Hexagonal incendiary bomb made of Nipolit, about one foot long and an inch to 1½" in diameter.

2. Mark IV clockwork delays with 6- and 28-day maximum delay time.

3. Hell- und Dunkel Zuender, or Verdunkelungs Zuender. A delay containing a selenium cell and a Leclanché battery. It can be made to function when light falls on the cell or when light ceases to fall on the cell. When the battery runs down, the delay functions automatically. It seems possible that about twenty of these were manufactured by KTI for VI-S.

4. A delay set off by a high frequency radio signal. Maximum signal distance 800m. These were in the experimental stage only.

5. Schienen Druck Zuender. A railway pressure igniter for attachment to a rail. The igniter remains inactive as long as there is no traffic on the line but is armed by the pressure of the first passing train. It can be adjusted for a maximum time delay after arming of 14 days. Possibly it is booby-trapped so that replacement of the metal safety pin in the safety pin hole causes it to function.

According to SKORZENY, plans for this igniter had been submitted by an outside inventor but it never reached even the experimental development stage.

6. Nipolit hand grenade with Allways fuse.

7. All-purpose Nipolit charge (Einheit Spreng Koerper) made jointly by Mil Amt D/T and WASAG. This charge weighs appr 300 and is rectangular in shape with grooves cut in each face, presumably to give a hollow charge effect.

8. Abscher Zuender. A delay operating on a shearing principle. A striker is held under spring tension by a metal shaft which under the tension of the spring gradually breaks. The body of the delay is telescopic in the sense that the tension of the spring can be adjusted by elongating the barrel.

VI-F was experimenting with this delay but it had not been put into production.

Poison Bullets

SUBJECT: The German Sabotage Services

DATE: 23 July 1945

SKORZENY has made the following admissions regarding the manufacture and issue of poison bullets under his direction:

Live Bullets

At SKORZENY's request the Kriminal Technisches Institut der Sipo, BERLIN, manufactured special 7.65 caliber pistol bullets containing poison. The poison was an aconite compound and escaped through slits in the sides of the bullets.

The bullets were supplied to SKORZENY at FRIEDENTHAL. He issued approximately six each to Hptm HELLMERS, CO of LSt II West fuer Front Aufklaerung in Oct 44 and to O/Stubaf HARDIECK of 150th Panzer Brigade in Nov 44.

SKORZENY at first tried to persuade the interrogators that these bullets were manufactured and issued solely for suicide purposes. He readily agreed, however, that HELLMERS was most unlikely to have wanted them for such a reason. He finally admitted that they were intended for assassinations. He claims that they were not to be used without special orders.

Simulated Bullets

SKORZENY admitted that special equipment was provided for suicide purposes in the form of poison ampules hidden in fountain pens, automatic pencils, cigarette lighters, and bullets. This bullet is not to be confused with those mentioned above. It is simply a receptacle for the poison ampule, and cannot be fired from a weapon.




