//ARGENTINA: THE ARGENTINE GUERRILLAS WHO KIDNAPED THE HONORARY US CONSUL IN CORDOBA ARE THREATENING TO KILL HIM UNLESS THE GOVERNMENT SHOWS THAT FOUR LEFTIST PRISONERS ARE ALIVE. THE GUERRILLAS SET A DEADLINE OF 6 P.M. ON FEBRUARY 28.//4

//LAST MONTH, ANOTHER TERRORIST GROUP GAVE PRESIDENT PERON 72 HOURS TO PROVE THAT 16 LEFTIST PRISONERS WERE ALIVE AND WELL. IN THAT CASE, THE THREAT WAS TO KILL GOVERNMENT EMPLOYEES AT RANDOM. PHOTOGRAPHS OF SOME BUT NOT ALL OF THE PRISONERS WERE PUBLISHED, AND THE TERRORISTS WERE APPARENTLY SATISFIED.//4

//FEDERAL POLICE OFFICIALS DO NOT BELIEVE THEIR SERVICE IS HOLDING ANY OF THE PRISONERS AND TWO OF THE MEN MAY HAVE BEEN KILLED BY PROVINCIAL POLICE IN CORDOBA ON SEPTEMBER 24.//4

//ON FEBRUARY 27, SECURITY FORCES ARRESTED A PHYSICIAN WHO MAY HAVE BEEN ON THE ABDUCTION TEAM; HE MIGHT BE ABLE TO LOCATE THE "PEOPLES PRISON" WHERE THE CONSUL IS BEING HELD.//4
