MKTOPAZ CATIDE

1. DURING JULY KUBARK BRIEFING FOR SENIOR CATIDERS, MKTOPAZ REP SHOWED PEPPERMILL AUDIO DEVICE, MADE GENERAL OFFER OF LOAN ALL DEVICES SHOWN. PETERSEN HAS REQUESTED SIX-WEEK LOAN PEPPERMILL OR SIMILAR DEVICE SUITABLE FOR USE IN SOPHISTICATED RESTAURANT WITH MODERN DECOR. ALSO NEEDS RECEIVER, TAPE RECORDER AND MONITOR EQUIPMENT FOR USE WITH DEVICE. TO BE USED CHECK BONAFIDES OF D/A DURING MEETING IN PUBLIC RESTAURANT. OPERATION IS POST-UJDROWSY D/A WHO HITHERTO UNPRODUCTIVE BUT NOW HAS LEGAL RESIDENT IN NEUTRAL COUNTRY AS OPPOSITE C.O. ONLY CATIDE STAFFERS TO BE WITTING OF PLANT.
