1. Complete Headquarters traces have been run on Friedrich or Fritz SCHWEED uncovering the interesting fact that, whereas SCHWIND has been informing on GLAVAN to the Boundorean Military Intelligence recently (Reference B), GLAVAN informed on SCHWEED to ODTORE back in 1947 or 1948. The two were apparently associated in the German IS during Harld War II.

2. Additional information was also uncovered on CLAVAN, supplementing the original information forwarded on him in HPIN-1935, although the latter reported GLAVAN to be a Communist, and the additional information states he is an anti-Communist. This information comes from SCHWEND, is evaluated B-2 and is dated 16 August 1946: "Louis GLAVAN is an interesting personality. He is of strong To argust 1945: "Jouls Glavia is an interesting personality. As is of strong character, decisive, cuming, and is a trader by profession. He purchases articles which are scarce in one country, and transports them, duty free, on his own ships, and sells them at high profit in another. He has done this for a long tike before and during the war. During the war he assisted SCHMEND in his RSHA (German State Security Service) financial operations: procuring rare articles, like cloth, uniforms, foreign money, papers, foreign weapons, etc., needed by RSHA to equip its foreign agents. GLAVAN never tas an employee of RSHA but had a percenal agree-ment with RSHA agent. SCHENEN. For this association with SCHENEND, GLAVAN was ment with RSHA agent, SCHWEND, For this association with SCHWEND, GLAVAN was arrested by CIC in Insbruck in July 1945 and until August 1946, remained in CIE/ Ludwigsburg. Upon release, GLAVAN passed through Munich, visited SCHWED, told bin about his future plans, and want to Italy. His plans are to buy a few boats and engage in "trade" between Spain, Korth Africa, Italy and the Balkans. He intends to settle under an alias in Ancone or in Bari. He can be contected through SCHMERD. to settle under an alias in Ancone or in Bari, The data on GLAVAN was gotten because it was felt that under certain circumstances he might be useful to us. During our interview with GLAVAN, it appeared that he is a capable, intelligent, dependable (though, nc doubt, without regard for law or regulations) and daring man, open for any proposition. Sauggling is GLAVAN's trade, and he can amuggle things, news, or people and keep his month shut. He has a high regard for SCHWERD, Data on GLAVAN: Born 28 March 1905 in Finne, Italy, (NOTE: Finne, Italy is now Rijeka, Yugoslavia; Susac, Yugoslavia, where Reference & report-ed he was born, is a smaller town next to Finne, to the southeast.) He is of Yugoslav descent, was a Yugoslav and an Italian citizen. His current citizenship is Italian. He graduated from Tugoslav OCS at Bilece; he holds the rank of captain in the reserve. He is an anti-Communist. Speaks Italian, German, Croat, Slovene well end some Bulgarian, Russian, Czech and Polish. He has an excellent knowledge of politics and people in Yugoslavia, Albania and Italy. He knows the Adriatio coast of Jugoslavia and Italy well; has personal and business friends there. He is in good relations with the dissident elements in Albania and Jugoslavia, especially Marco BERANI and Boy Ali DRAGA." (NOTE: According to the area deak, "dissident elements" in Albania and Tugoslavia in 1916 were probably anti-Communist, as the Communist regimes were by then fairly well established in those countries.)

3. The following are the traces on SCHMEND; they are reported in some detail because of the complexity of the case:

JRI-1147, 13 August 1945; an interrogation report on German IS activities in Italy during World War II: SCHWENDT, alias WENDID, P. W. Leader of the WENDIG group, at Trieste and about autumn 1944 at Merano. Said to have returned from the U.S. before the war, and to own hotels in the Dolomites.

A report dated 15 June 1947, probably from OSS, balieved to be an extract from a list of dropped agents, stated that SCHERED was formerly in charge of the purchasing agents for RSHA, Ant II, and was used by (OSS Ramich to locate valuables accumulated by the RSHA. . . . Since the end of that operation, he had furnished several reports dealing with personalities and groups in Italy, Fugerlavia and Germany. . . . Sometime early in 1947 he emigrated to Brasil, but as of the above date, was still writing to his (OSS) Humich case officer.

c. FEAN-528, to Washington, Munich, Heidelberg, 27 January 1948: ODDI ENCOM received a letter written by one Vjekoslav A. CLAVAN to General Clay through the American Ambassador Rome, concerning Frits SUMMEND, buyer for Ant II RSMA, whe was used by (OSS) on bird-dogging operation from July to September 1945. GLAVAN maintains that SUMMEND and uife Redda are now living in Line, Peru, under the name Venceolau TURI, driving yellow Chevrolet N 897h. Claims G. SPITZ, Munich Jew, aided SUMMEND in permeding Americans not to present him for Kani astivities. Claims SUMMEND living from proceeds RSMA funds he succeeded in computer ing from Americans and which are forwarded to him by one Carl Flutterlieb, Geneva. Also living off investments under with above-mantioned funds. Allegedry supply Flutterlieb with money for SUMMEND. GODI andre (OSS) involved in case, since cables from 2/SUMMEND. GODI andre (OSS) Flaces chrises current status SUMMEND.

d. HEID-2010, to FRAH, info to HASH, HUEL: 27 January 1948: No connections with SCHWEND. In Farch 1947 I reported SCHHEND had gone. Italy and emigrated Brazil. Vietoslav A. GLAVAN possibly identical Louis GLAVAN who is Ostober 1945 was about to start shipping business with SCHENED in Italy. GLAVAN was borz 25 March 1905 in Fixed; assisted SCHENED in HERA financial operations. Has arrested by CID and interned Intendesburg Saly 1945 to August 1945. (Additional information follows, en G. Spits and Giovanni Kawhold.)

c. MASE-2061 OFF-58113, to [] 30 January 1948: OBIBER Generary reports one Frits SCHNEED, alian MEEDIM, Foreign Currency operator of Cornan IS, and wife Modda now living Lina under mane Venceslau TURI. Drives yellow Chevrolet N 3978. Subject arrested and interrogated by OSS in June 1945 in attempt to recover hidden General IS funds. Reported presently living from presents these funds he successed in cusouflaging from the Americans. (Reported to () in HPLA-3558, 25 Novamber 1959.)

1. TFIN-275, 5 February 1948: Frits SCHWEND worked for the German Intelligence Services in various capacities begining in 1940. In 1983 Hainrich HINFIES ordered the manifecture of false corrency with the intention of selling it in occupied Europe against gold, jewels, and other valuebles. Valuebles thus purchased were to be used to finance GIS operations. A Br. HENDIG was appointed head of this operation. After his death in 1944, Subject took charge, using the name WENDIG. As the allied armies sivenced in Germany, SCHWEND executed to Harmon in North Italy with stocks of the faked currency and valuebles. He was arrested in about Nay 1945 and was interregated in an effort to determine the whereabouts of other persons involved in the operation, as well as to discover the location of funds and valuebles, which constitued a threat to Allied security as they could have been used to finance antiallied post-war activities. Subject was used by CSS on this bird-dogging operation from July to Hovenber 1945 as a casual informant by the Humich Station. The last report from his was dated 28 August 1946. In Harch 1947 the Humich Station reported that SCHWEND had gone to Italy and from there had emigrated to Branil. After his departure from Euclide he worde twice to his former case officer ________enderstill, Esthing further has been heard to our knowledge. . . . SCHWEND lived for some years in the U.S., where he had wealthy aunts. After this sojourn in the U.S., he had returned to Europe to existister the European fortunes of these somes.
