Subject: SI and H Experimentation, 30 January 1952

On Wednesday, 30 January 1952, SI and H experiments were carried on in Building 13, Room 20, with [REDACTED] attended primarily as an observer by [REDACTED]. For a matter of record, [REDACTED] came in shortly after the work had begun.

As stated above, [REDACTED] had attended primarily as an observer but in view of her excellent capacity as a hypnotic subject, the writer asked [REDACTED] to demonstrate some of her ability in hypnotic work for the benefit of [REDACTED]. Accordingly, the writer placed [REDACTED] in a deep trance state in a matter of a few seconds and transferred control of her to [REDACTED] and he showed [REDACTED] how [REDACTED] could open her eyes, carry on a normal conversation, act, look, laugh, etc. and still remain in a very deep trance state. After [REDACTED] had demonstrated this for about five to six minutes, [REDACTED] awakened her by the usual 12345 method.

After some discussion of the general subject and remarks on [REDACTED] demonstration, the writer, using a slow relaxation technique, placed both [REDACTED] in a medium trance state for approximately ten minutes. He thereafter returned both girls to an awake state, using the usual post H suggestion regarding sleep, by the 12345 method.

[REDACTED] then using a more rapid technique, placed [REDACTED] in a medium trance state and tests were made for depth through various standard experiments such as opening eyes, inability to move the arm, arm catalepsy, etc. In addition, [REDACTED] carried on a brief conversation with [REDACTED] then awakened [REDACTED] by the 12345 method after he gave her a post H suggestion that when he tapped the back of his chair with a pencil, she would immediately go to sleep. Shortly after awakening [REDACTED] [REDACTED] tapped the back of his chair with a pencil and [REDACTED] responded and went into a good, medium trance state. [REDACTED] awakened her from this by the 12345 method.

After a short discussion, [REDACTED] then using the same short method, placed [REDACTED] in a lighter trance state and tested her for depth with the opening of the eyes, arm catalepsy, etc. [REDACTED] then carried on a brief conversation with [REDACTED] and awakened her by the 12345 method after giving her a post H suggestion that when the

chair on which [redacted] was sitting moved a certain way [redacted] would fall asleep. Shortly after [redacted] was awakened [redacted] moved the chair and [redacted] and went immediately into a hypnotic trance state. [redacted] awakened her using the usual 12345 method.

After a brief discussion concerning the hypnotic state induced, [redacted] placed both girls rapidly in a medium trance state. Thereafter using a microphone, [redacted] asked a series of questions with [redacted] tape recorded the answers. [redacted] being held in a trance state during the entire conversation. [redacted] then turned the mike over to [redacted] who questioned [redacted] briefly. However, the one point during the questioning, [redacted] shifted her body and blinked her eyes as though she were awakening and [redacted] immediately stopped the questioning. Shortly thereafter [redacted] awakened both girls by the usual 12345 method and with the usual precautionary suggestions.

The work was concluded short before 9:00 PM.
