MGLA 8540 (ENROUTE) RELATES SKORZENY APPROACH TO ZIPPER, VIA FNU SCHNEETZ OF STUTTGART, ORGANIZER OF "SOUTH GERMAN SOLDIERS SELF-AID" (PROBABLY IDENTICAL WITH ALBERT PAUL SCHNEZ OF MGLA 7152), SEEKING CONTACT WITH ZIPPER REGARDING HIS PENETRATION OF RIS NETWORK PENETRATING BONN AND HICOG. SKORZENY EITHER GAVE OR SHOWED ZIPPER CONTACT 20 SAMPLE REPORTS OF "RIS NETWORK" INCLUDING MEMORANDUM FROM FRENCH MINISTRY OF DEFENSE TO PONCET CONCERNING GERMAN REMILITARIZATION AND PARIS TALKS; CONFIDENTIAL REPORTS CONCERNING FRICTION BETWEEN EISENHOWER AND MONTGOMERY; "PROTOCOL" OF A CONFERENCE BETWEEN ADENAUER, MCCLOY AND BUTTENWIESER; PLANS OF ROTHSCHILDS AND LURGI FIRM TO MONOPOLIZE LEATHER MARKET. SKORZENY WILLING TO MEET ZIPPER REPRESENTATIVE IN WEST GERMAN PROVIDED HE RETAIN CONTROL OF HIS PENETRATION GROUP.

2. ZIPPER FEELS COMPLETE FABRICATION UNLIKELY SINCE SOME OF THE REPORTS DETAILED ENOUGH TO BE CHECKED BUT FEELS APPROACH COULD BE (A) DIRECT RIS PROVOCATION; (B) PEDDLING RING; (C) ATTEMPT OF CERTAIN RIS AGENTS TO BUY "INSURANCE" FOR CONTINUED ACTIVITY. ZIPPER OBSERVES THAT SKORZENY PROBABLY MADE SAME OFFER TO OTHERS SINCE HIS "RIS REPORTS" WERE CARBON COPIES. ZIPPER SPECULATES THAT HE IS ALSO PROBABLY IN TOUCH WITH AIS THROUGH US EMBASSY MADRID.

3. ZIPPER ASKS FOR GUIDANCE CONCERNING FURTHER STEPS.

4. MGF 787 (ENROUTE) COVERS CAROTID REPORT OF HIS RECENT CONVERSATIONS WITH SKORZENY IN MADRID. SKORZENY REVEALED HIS "PLAN A" CONCERNING ANTI-COMMUNIST ALERT UNITS FOR EVERY WESTERN EUROPEAN COMMUNITY AND "PLAN B" FOR COMMANDO UNITS. NO MENTION OF RIS PENETRATION IN THIS REPORT.
