SUMMARY OR SID REPORT: German ex-Colonel Otto SKORZENY arrived in Egypt from ESTERES, UGANDA via Sabena Airlines on 11 June 53. It is believed that prior to his visit to Egypt he visited PAKISTAN. He departed from Cairo on 14 June 53. This visit is confirmed by the Counselor of the German Embassy, Lt Col Gamal Abdel NASR, and the Egyptian press. COMMENT (Of Preparing Officer):

1. Reports indicate that this latest visit to Egypt by SKORZENY was for the purpose of peddling small arms and for offering his services in guerrilla training of Egyptians. It was reported that he had no success in his small arms dealing and that he was turned down in his suggestion that he train guerrillas. It is understood that he asked for a salary of 350 Liras a month, and it is variously reported that his services were not accepted because of (a) the amount of salary demanded and (b) because his presence in Egypt would be offensive to the Western Powers.
2. There appears no doubt that SKORZENY failed in his mission and that he left Egypt disgruntled.
3. It is reported by the German Embassy Counselor that SKORZENY's representative in Egypt is Mr. BEISSNER.
