Although SKORZENY undoubtedly has a certain number of friends within UPHILL through whom UPHILL is able to keep track of his activities, we strongly doubt that UPHILL has any kind of regular contact with SKORZENY. The Chief of UPHILL has always professed to have a very low opinion of him, and several years ago warned that support of SKORZENY by a U.S. Agency in Spain would eventually be the source of embarrassment to the U.S. Government. At an appropriate opportunity, we shall attempt to determine whether there is any new information concerning UPHILL's attitude towards SKORZENY.</p> <p>2. It seems unlikely that UPHILL/<input type="checkbox"/> relations play a role in reference affair. As far as we can determine from recent comments by members of UPHILL, current liaison between these two services is not very close.</p>
