1. NAVY OFFICIALS CONFIDENTIALLY INFORMED EMBOFFS

TODAY (3/16) THAT NAVY WILL PROPOSE AT MARCH 27 SECRETARIES GENERAL THAT

JACOBO TIMERMAN BE TRANSFERRED TO HOUSE ARREST.

NAVY OFFICIALS STATED THAT THEY THOUGHT THE

GROUNDWORK HAD BEEN LAID FOR ACCEPTANCE OF THIS

PROPOSAL BY THE OTHER SERVICES.

2. THEY ALSO SAID THAT THE NAVY IS CONSIDERING

PROVIDING GUARDS FOR THE PROTECTION OF TIMERMAN.

THEY EXPRESSED SERIOUS CONCERN REGARDING TIMERMAN'S

BEING AN ATTRACTIVE TARGET FOR BOTH LEFT AND RIGHT

WING FORCES TO EMBARRASS THE GOVERNMENT.
