WE ARE REPEATING FOR YOUR INFORMATION THREE REFTELS WHICH RELATED TO INFORMATION IN THE POSSESSION OF BOSTON GLOBE CORRESPONDENT JOHN BIERMAN CONCERNING THE CASE OF RAOUL WALLEMBERG, A SWEDISH DIPLOMAT WHO WAS SWALLOWED UP IN THE SOVIET PRISON SYSTEM AFTER WORLD WAR II. SPECIFICALLY, WE ARE TRYING TO FIND OUT WHAT BIERMAN HAD IN MIND IN SUGGESTING TO EMBASSY TEL AVIV THAT HE KNOWS OF A MAN IN SWEDEN WHO CLAIMS TO HAVE SEEN WALLEMBERG. WE WOULD APPRECIATE AN EFFORT BY EMBASSY LONDON TO FOLLOW UP THIS POINT WITH BIERMAN, WHO WE UNDERSTAND CAN BE CONTACTED IN LONDON THROUGH THE BBC.
