2. DEPARTMENT LEARNED THE FOLLOWING SEPTEMBER 7 FROM
SENATOR BIDEN'S STAFF, WHICH ALSO HAS BEEN PASSED TO
SWEDISH EMBASSY HERE BY BIDEN'S STAFFER.

3. SENATOR BIDEN HAD PLANNED TO SPEAK TO BREZHNEV ABOUT
WALLEMBERG, BUT AS YOU MAY KNOW HE DID NOT MEET BREZHNEV.
INSTEAD, BIDEN RAISED CASE WITH TWO SENIOR MEMBERS OF THE
SUPREME SOVIET (REFTEL 8). THEY PROMISED A RESPONSE.
SENATOR BIDEN ALSO SENT A LETTER TO BREZHNEV OUTLINING
HIS INTEREST IN THE CASE.

4. AS NOTED PARA 2 ABOVE, DEPARTMENT PRESUMES SWEDISH MFA
