[] THE BRAZILIAN DECISION HAD BEEN MADE PROBABLY DURING THE
31 MAY-2 JUNE 1976 CONDOR MEETING HELD IN SANTIAGO, CHILE WHEN
BRAZIL, THROUGH ONE OF ITS OBSERVERS, HAD AGREED TO MEMBERSHIP
IN THE CONDOR ORGANIZATION. [] IN AGREEING TO 3.3(b)(1)

MEMBERSHIP AND TO SUPPORT OF THE CONDOR ORGANIZATION, BRAZIL HAD
TAKEN A VERY AGGRESSIVE POSTURE AND HAD TRIED TO USURP LEADERSHIP,
AN ACTION THAT DID NOT SIT TOO WELL WITH THE REST OF THE MEMBER-
SHIP. [] AS A RESULT OF THE STRONG NEGATIVE REACTION OF
OTHER CONDOR MEMBERS TO ITS ACTION, BRAZIL SINCE THEN HAD DECIDED
TO REMAIN ON THE PERIPHERY OF THE ORGANIZATION MERELY AS AN OB-
SERVER AND THAT AS OF THE 3-6 OCTOBER 1977 MEETING OF THE III
CONFERENCE OF THE CONDOR ORGANIZATION IN BUENOS AIRES, WHEN BRA-
ZIL DID NOT SEND ANYONE, IT COULD BE CONSIDERED EFFECTIVELY OUT
OF THE CONDOR ORGANIZATION.
