SUBJECT: ALIAS ACKERMANN VISIT

1. DURING HEADQUARTERS DISCUSSIONS WITH ALIAS ACKERMANN, HE INFORMED US /HAT HE WILL BE VISITING VIENNA 8 JUNE WITH "THE BLUM PARTY "(NFI)". ALIAS ACKERMANN STATED THAT HE WOULD IN ALL PROBABILITY CALL ON

2. REGARDING JOINT OPERATIONS IN VIENNA, THE MAIN THRUST OF THE CONVERSATION CENTERED AROUND THE LHDEN TARGET. IT WAS AGREED THAT THERE COULD BE MERIT TO A COORDINATED EFFORT AGAINST THIS TARGET. AS A FIRST STEP, EACH SERVICE COULD POSSIBLY LOOK AT THEIR RESPECTIVE HOLDINGS ON LHDEN PERSONALITIES AND THAT THIS INFORMATION COULD BE SHARED. THERE WAS NO DOUBT THAT BOTH CASCOPE AND PNXCEL RECEIVE INFO FROM DIFFERENT SOURCES AND THAT BY SHARING WE COULD PUT TOGETHER MORE COMPLETE INFORMATION ON TARGET PERSONALITIES. HOWEVER, WE AGREED TO STUDY THIS MATTER FURTHER AND NO FIRM COMMITMENTS WERE MADE OR GIVEN.
