HEADQUARTERS HAS ALREADY DISSEMINATED SOME INFORMATION CONCERNING THESE ACTIVITIES TO HIGHEST LEVEL OF LNHP AND ANTICIPATES FURTHER SUCH REPORTS IN THE NEAR FUTURE.

ALSO ADVISE HIM THAT STATION WILL HANDLE TRACES ON INDIVIDUALS MENTIONED IN PARA 3 REF. SUGGEST YOU EXPLAIN TO LNERGO REP IN GENERAL TERMS THAT RVROCK POLICY ON HANDLING OF THESE MATTERS REQUIRES THAT INFO OBTAINED BY LIAISON BE FORMALLY DISSEMINATED THROUGH RVROCK HQS AND THAT ANY INFO PASSED Laterally TO HIM BY THE STATION IS FOR HIS INFO ONLY. HE SHOULD BE ADVISED THAT HE IS, OF COURSE, FREE TO TRANSMIT ANY OF THIS INFO TO HIS HQS IF HE FEELS THIS IS NECESSARY BUT WITH CAVEAT THAT INFO IS NOT TO BE FURTHER DISSEMINATED. BY LNERGO.
