2. THE FARM IS LOCATED SOUTH OF MEDELLIN OUTSIDE OF ENVIGADO, ANTIOQUIA DEPARTMENT, NEAR AN UNINCORPORATED AREA CALLED "PALMAS DE MALLORCA. " THE FARM CAN BE LOCATED BY TRAVELLING SOUTH ON THE ROAD FROM MEDELLIN, THROUGH EL POBLADO AND THROUGH ENVIGADO, TO PALMAS DE MALLORCA. PALMAS DE MALLORCA CONSISTS OF A LARGE COMPLEX OF APARTMENT BUILDINGS. APPROXIMATELY ONE OR TWO HUNDRED METERS SOUTH OF THIS COMPLEX IS ANOTHER SMALLER GROUP OF APARTMENTS ON THE LEFT HAND SIDE OF THE ROAD. THE ENTRANCE TO THE FARM IS LOCATED ON THE LEFT HAND SIDE OF THE ROAD APPROXIMATELY ONE THOUSAND METERS SOUTH OF THAT SECOND SMALLER COMPLEX OF THE PALMAS DE MALLORCA APARTMENTS. THE HOUSE SITS BACK FROM THE ROAD.
